In continuation to the reference 8<sup>th</sup> cited above, it is informed that, vide the reference 9<sup>th</sup> cited above, the Prl.CCF & HoFF, TS, Hyderabad had issued a revised demand notice on cost of RCC Pillars only and there is no changes in respect of NPV and CA for diversion of 1.0935 Ha of Forest land in Nalgonda division for laying of Optical Fiber Cable along the road for execution of T-Fiber Project in favor of M/s Telangana Fiber Grid Corporation Limited, Hyderabad.

In view of the above, the UA is requested to deposit the following payments

as mentioned below.

I. **Towards NPV and other charges as shown below.**

Further the User Agency shall pay an amount of **Rs. 11.092 lakhs** towards CA (DFL) Scheme. The Compensatory afforestation in Degraded Forest Land over an extent of 2.187 Ha (Double the extent of diversion area proposed -  $1.0935 \times 2 = 2.187$  Ha) identified in compt.no.72 of Nellikal Beat, Nellikal RF of Nagarjuna Sagar Range of Nagarjuna Sagar Division.

As per the Government of India condition No. (vii), the User Agency should compulsorily deposit the above NPV & CA amount to CAMPA only through e-portal (<http://parivesh.nic.in/>); The User Agency (UA) will be informed that as per the guidelines issued by MoEF&CC, GoI the mode of remittance for compensatory levies shall be through **e-payment portal of Ministry of Environment, Forest & Climate Change only**. The User Agency has to upload the demand notice received in the Ministry's portal at <https://parivesh.nic.in/>: against the project for approval by the Nodal Officer, FCA, Telangana State. After approval of demand notice, then challan has to be generated and payment to be made against the bank account number indicated in the challan. Amount deposited through other mode will not be accepted. The detailed procedure for generation of Challan and deposition of funds is available at <https://parivesh.nic.in> portal.

1. The UA shall comply with the following in accordance with the MoEF&CC, Gol instruction issued vide F.no.7-23-2012-FC, dt.24-07-2013 communicated vide Prl. Chief Conservator of Forests, A.P. Hyderabad Rc.No.45921/2001/F4, dt.23-08-2013:
  - i. Publish the entire forest clearances granted in verbatim along with the condition and safe-guards imposed by the Central government in two widely circulated daily newspaper one is vernacular language and the other in English granted to the project proponent for the use of forest land for the non-forest purposes.
  - ii. The copies of the forest clearance should also be submitted to the heads of local bodies, Panchayats and municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days.
2. The transfer of forest land to User Agency shall not be affected prior to the issue of final (Stage II) Clearance from IRO, MoEF&CC, Gol and will be requested that no work in violation shall be carried out.

3. The User Agency will be informed that this in-principal approval is valid for the period of (5) years. In the event of non-compliance of the above conditions, this in-principal approval shall automatically stand revoked after (5) years.

The UA will also be requested to note the other conditions stipulated and implemented and furnish the compliance on the conditions stipulated, along with the necessary undertakings on C. No.(1) to (20) in Gol, MoEF & CC, IRO, Hyderabad, Telangana F.No.4-TSB281/2022/HYD/ 730, Dt:27.09.2022 communicated through PCCF (HoFF), TS, Hyderabad Rc.No.FC3/FC15/10/ 2022-FCA Section, Dt:06.10.2022

and evidence of payment of compensatory levies to District Forest Officer, Nalgonda for submission through Chief Conservator of Forests/ Conservator of Forests for onward submission to Government for obtaining Stage-II approval.

It is further clarified that, **Until the clearance/permission from the monitoring committee of ESZ is obtained by the User Agency,** the compliance report shall not be further forwarded.
