Vide above referred letter The Central Government has given 'in-principle' approval under Section - 4 of the Forest (Conservation) Act, 1980 for Diversion of 12.2607 ha. Of forest land in favour of Thane Municipal Corporation for Construction of Balkum to Gaimukh DP Road (NH3 Connector Ghodbunder By - Pass) in Taluka Thane, District -Thane in the State of Maharashtra subject to fulfilling certain conditions.

With regards to condition iv, v(a), vi, x and xviii the user agency is directed to submit compliance as follows: -

A) Cost of compensatory Afforestation Scheme at the prevailing wage rate at the time of plantation and maintenance for 10 years amounting to Rs.1,26,76,920/- (One Crore Twenty-Six Lakhs Seventy Six Thousand Nine Hundred and Twenty only)(As per ready reckoner issued by PCCF HoFF M.S. Nagpur dt.04/10/2019 @ Rs 845128/ha. for the year 2024-25.) B) User agency is required to pay the cost of survey, demarcation and erection of Permanent Pillars for Diverted Forest Area amounting to Rs. 12,77,979/- (Twelve Lakhs Seventy-Seven Thousand Nine Hundred and Seventy-Nine only) C) User agency is required to pay Net Present Value for 12.2607 ha. of mangrove forest land to be diverted amounting to Rs. 1,76,14,580/- /- (One Crore Seventy-Six Lakhs Fourteen Thousand Five Hundred and Eighty only). D) User agency is required to deposited Rs.3,62,30,574/- (Three Crores Sixty-Two Lakhs Thirty Thousand Five Hundred and Seventy-Four only) towards carrying out avenue plantation by planting 8 feet tall suitable forestry species outside ROW passing through the forest areas as well as non-forest areas. |
