I am directed to refer to the Government of Himachal Pradesh's letter No. 48-3920/2019(FCA) dated 18.05.2020 and letter No. Ft.48-3920/2019 (FCA) dated 11.09.2020 and **Online Proposal No. FP/HP/HYD/39709/2019** on the above mentioned subject, regarding seeking prior approval of Central Government under Section-2 of the Forest (Conservation) Act, 1980, and to say that the said proposal has been examined by the Forest Advisory Committee (FAC) constituted by the Central Government under Section-3 of the aforesaid Act.

2. After careful consideration of the proposal of the Government of Himachal Pradesh and on the basis of the recommendations of the Forest Advisory Committee, the Central Government hereby agrees to accord "Inprinciple" approval under the Forest (Conservation) Act, 1980 for use of additional forest area of 0.9486 ha (in addition to the already diverted 98.1004 ha) in favour of SJVN Ltd. for Luhri HEP Stage-I for construction/widening of approach road under the jurisdiction of Ani at Luhri Forest Division and District Kullu, Himachal Pradesh subject to the following conditions;

(b) Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India, shall be charged by the State Government from the User Agency. The User

After receipt of the report on compliance to the conditions stipulated in the paragraph-2 above, from the Government of Himachal Pradesh, final / stage-II approval for diversion of the proposed forest land under Section-2 of the Forest (Conservation) Act, 1980 will be issued by this Ministry. Transfer of the said forest land to the user agency shall not be affected by the Government of Himachal Pradesh till final/stage-II approval for its diversion is issued by this Ministry.


