With reference to the above cited letter on the subject, it is to inform that the Govt. of India MOEF & CC vide their letter No. 8-01/2020-FC dt. 28.07.2021 has accorded in-principle approval under section -2 of the Forest (Conservation) Act ,1980 for non-forestry use 783.275 ha forest land for Naini open cast project (Coal Mine) of M/S the Singareni Collieries Company Ltd of Chhendipada Range , Angul District.

Hence, as per the condition No. A-1(i), A-1(ii) and condition A-9 of the approval order by GOI, MOEF, you are requested to deposit the revised an amount of = Rs 20.00 crore/- towards the Ad-hoc cost of RWLMP and 5 crore for SMC plan for approved non forestry use of 783.275 ha of forest land as per the calculation given below in the Ad-hoc CAMPA in the saving Bank Account No. 520101263743655, Corporation Bank, Lodhi Complex, Ground Floor, Block No. 11, CGO Complex, Lodi Road New Delhi through "e" payment immediately and intimate the same to the undersigned for taking further action in the matter.

It is to be noted that revised calculated amount is completely provisional and based on the undertaking submitted by you vide letter under reference 6 as total project cost has not been submitted by the user agency due to non-engagement of Mine Developer-cum-Operator (MDO) at present stage and recurring nature of revenue expenditure as per project cost. Pending submission of updated project cost by the user agency in concurrence with competent authority, initial total capital outlay of 1000 crores only has been considered for calculation of Ad-hoc lump sum amount of 2% and 0.5% of the estimated capital outlay for the purpose of present calculation of ad-hoc demand for Regional Wildlife Management Plan & SMC Plan.

This demand is without any prejudice to the condition that payment of any deficit amount arisen due to changed, updated or revised project cost shall be deposited and shall be intimated to and concurred by the concerned IRO of the ministry before actual breaking/Non forestry use of the forest land.
