A Copy of the above reference are enclosed here with in which the Government has called for details regarding work in violation of Forest Conservation Act 1980, has been uploaded in the Par-II of Form - hence the work violation amount have been fixed as Government of India New Delhi guide line as follows :

1. Violation area 0.025ha X NPV Rs 6.99 lakhs/ ha = Rs 17,475
2. As per guide line 5 times 17475 X 5 = Rs. 87,375.00
3. 12% Interest (from 2008 to 2018) 87375X12 % =Rs 10485.00
4. 2008 July month to December 2008 =
5. 10485/2= 5,243.00+87375 = Rs 92618.00
6. 2009 to 2018 - 10 Years X 10485 = Rs. 1,04,850.00

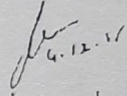

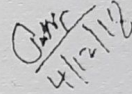
