It is submitted that the Government, vide reference 7th, has accorded **in-principle (Stage-I) approval**, for diversion of forest land to an extent of **6.926 ha** of forest land in Erstwhile WLM Division, Paloncha of Khammam District and presently falling under the jurisdiction of Forest Divisional Officer, WLM Division, Kinnerasani of Bhadradri Kothagudem District, for laying of Pipeline and Construction of structures for **Segment-25/7 (Banjara)**, under Telangana Drinking Water Supply Project, in favour of Superintending Engineer, TDWSP (RWS&S) Circle, Khammam. The above orders have been communicated to all the concerned officers to obtain the the condition-wise compliance report from the UA, vide reference 8th cited.

Accordingly, vide ref 9^{th} cited, the Chief Conservator of Forests, Kothagudem had obtained compliance of conditions from the Forest Divisional Officer, Kinnerasani WLM and User Agency and submitted to this office. A copy of reference 9^{th} cited together with its enclosures **in triplicate is** enclosed herewith.

The condition-wise compliance report is reproduced with remarks as follows:
