Attention is invited to the above subject. AIGF(Central), MoEFF & CC, Bangalore have accorded Stage-I approval for diversion of 0.0243 Ha (2 locations) of forest land for laying drinking water pipeline at Randampuzha through vested forests in Kizhakkanchery Grama Panchayath of Palakkad District, which is vested forests of Puzhakkalidam Malavaram (VFC-37/1) under Mangalamdam Forest Station in Alathur Range of Nemmara Forest Division vide order cited and directed to issue the demand notice to the User Agency for submitting / uploading the compliance report alongwith undertaking in stamp paper worth Rs.200/- stating all the conditions are complied in the stage – I approval.

As per the existing guidelines and relevant orders, **NPV is exempted for Drinking Water purpose (Laying of underground drinking water pipeline up to 4" diameter).**

**Rs. 3,00,000/- is to be remitted being the cost of planting and 10 year maintenance charges of 100 trees under CA scheme.** (0.1 Ha of degraded forest land has identified at Kavussery VF Malavaram Bit-III under Choolannur Section of Alathur Range in Nemmara Division for planting and 10 year maintenance charges of 100 Nos. of trees) to be remitted through e-portal (PARIVESH) and necessary receipt of **Rs. 3,00,000/- (Rupees Three lakhs only)** remitted amount and compliance report along with undertaking in stamp paper worth Rs. 200/- stating all the conditions are complied in the stage – I approval should be submitted / uploaded (PARIVESH Portal) at the earliest.
