विषय: श्योपुर जिले में नवीन राष्ट्रीय राजमार्ग क्रमांक-552 सवाई माधोपुर-गौरस मार्ग के विस्तारित/ चौड़ीकरण हेतु 20.568 हेक्टेयर आरक्षित एवं संरक्षित वनभूमि कार्यपालन यंत्री, लोक निर्माण विभाग, राष्ट्रीय राजमार्ग संभाग ग्वालियर को उपयोग पर देने बाबत ।

Sir,

I am directed to refer to the PCCF (LM), Govt. of MP letter Nos. F-5/1091/2021/10-11/395 dated 01/02/2022, 2152 dated 20/06/2022 and 2455 dated 14/07/22 of PCCF (LM) and Nodal Officer, Govt. of Madhya Pradesh, wherein prior approval of the Ministry of Environment, Forest and Climate Change for diversion of 20.568 ha Reserved & Protected Forest land for expansion/ widening of Sawai Madhopur-Goras Road (Newly NH No. 552 ext.) in favour of Executive Engineer, Public Works Department, National Highway Division in Sheopur District of Madhya Pradesh, was sought in accordance with Section-2 of the Forest (Conservation) Act, 1980. After due consideration of the proposal of the State Government, the 'in-principle' approval of the Central Government for diversion of the said forest land was accorded vide this office letter dated 21/09/2022 subject to fulfillment of certain conditions. The APCCF(LM), Govt. of Madhya Pradesh vide his letter No.F-5/1091/2021/10-11/590 dated 29/01/2024 has furnished compliance report in respect of the relevant conditions stipulated in the in-principle approval for grant of final approval.

In this connection, on the basis of the compliance report under reference and confirmation of receipt of compensatory levies from National Authority of CAMPA dated 27/06/2023 the **final approval** of the Central Government under Section 2 of the Forest (Conservation) Act, 1980 is hereby accorded for diversion of 20.568 ha Reserved & Protected Forest land for expansion/ widening of Sawai Madhopur-Goras Road (Newly NH No. 552 ext.) in favour of Executive Engineer, Public Works Department, National Highway Division in Sheopur District of Madhya Pradesh, subject to following conditions and stipulations:-

- (1) Legal status of the forest land diverted shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the Forest Department over **42.00 ha degraded forest land at Comptt. No. RF-146, Gram Van Samiti-Bagvaj, Tehsil-Sheopur, District-Sheopur** at the cost of the User Agency. As far as possible, a mixture of local native species shall be planted and monoculture of any species shall be avoided.

- (3) The State Government shall ensure that compliance of Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 has been completed in accordance with the relevant Rules and Guidelines issued by the MoEF&CC, GoI in this regard.
- (4) User Agency shall restrict the felling of trees up to **3684 enumerated numbers or any minimum number** in the diverted forest land and they shall be felled under the strict supervision of the State Forest Department or the cost of felling of trees shall be deposited by the User Agency with the State Forest Department and the State Forest Department.
- (5) **The User Agency shall raise plantation on central verge of the road as per IRC norms.**
- (6) **Roadside plantation shall be carried out by the Forest department at the cost of the User Agency as per IRC norms.**
- (7) Speed regulating signages shall be erected all along the road at regular intervals in the Protected Areas/ Forest Areas.
- (8) The User Agency shall obtain Environmental Clearance as per provisions of the Environmental (Protection) Act, 1986, if applicable.
- (9) Boundary of the diverted forest land shall be demarcated on the ground at the project cost, as per directions of the concerned DFO.
- (10) Layout plan of the proposed diversion of the forest land shall not be changed without prior approval of the Central Government.
- (11) No additional or new path will be constructed inside the forest area for execution of the project work.
- (12) No labour camp shall be established inside the forest land.
- Hand* (13) The User Agency shall provide alternate fuels preferably LPG to the labourers and staff working at the site so as to prevent any damage and pressure on the nearby forests.
- (14) The diverted forest land shall not be used for any purpose other than that specified in the project proposal.
- (15) The period of diversion under this approval shall be co-terminus with the project life.
- (16) The diverted forest land shall under no circumstances be transferred to any other agencies, department or person without prior approval of the Central Government.
- (17) The User Agency shall provide suitable under/ over passes in Protected Area/ Forest Area as per recommendation of CWLW/ NBWL/FAC/ REC, if applicable.
- (18) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time being in force, as applicable to the project.


(19) Violation of any of these conditions will amount to violation of the Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.

(20) All the conditions of Stage-I approval dated 21/09/2022 shall be strictly complied.

(21) Any other condition that the Ministry of Environment, Forest & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests and wildlife.

As has been mentioned at Para-2 of the Stage-II approval, this approval for diversion of forest land is subject to the fulfillment of stipulated conditions mentioned in this approval letter. Therefore, in the event of non-compliance of any of the conditions laid out in this approval letter, the Regional Office of Ministry of Environment, Forest & Climate Change may withdraw the said approval for diversion of the forest land and stop all the non-forestry activities being carried out in the forest land besides initiating legal action as per provisions of the Forest (Conservation) Act, 1980.


