

b	The demarcation of the proposed forest area shall be carried out by the user agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.	The user agency has demarcated the area by erecting cement concrete pillars duly numbered at an interval of 20 meters at their cost.
c	The User Agency has to pay the amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India.	The user agency has deposited the Net Present Value of Rs. 12921/- in State CAMPA fund in the Corporation Bank New Delhi by generating challan in the Ministry web portal on 16.11.2020. A copy of chalan is enclosed.
d	The user agency has to bear the additional amount of Net Present Value (NPV) which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.	The User Agency has furnished an undertaking to this effect. The same is enclosed.
e	The user agency has to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.	The User Agency has furnished an undertaking to this effect. The same is enclosed.
f	The total forest area utilized for the project shall not exceeds 0.0295 ha comprising water supply pipeline to a length of 295m and width is 1.00m and after completion of underground laying of pipeline, area shall be restored to its normalcy.	The User Agency has furnished an undertaking to this effect. The same is enclosed.


Condition No.	Conditions stipulated by the Government	Compliance of condition/ reply
g	Period of lease can be twenty (20) years. The user agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department in case the user agency wants to extend the lease.	The User Agency has furnished an undertaking to this effect. The same is enclosed.
h	The District Forest Officer may impose any other condition in the interest of conservation/ protection and development of forests.	The User Agency has furnished an undertaking to this effect. The same is enclosed.
