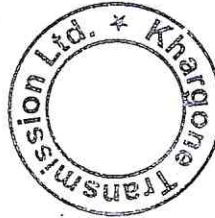

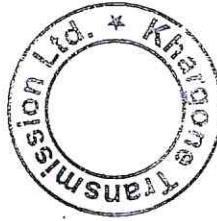

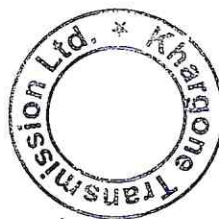

UNDERTAKING

1. Legal Status of the forest land will remain unchanged.
2. User Agency has got permission on Non forest land as per Gazette Of Indi
3. The Compensatory Afforestation to be taken by forest department on over 79.50hac. in double degraded forest land. The amount for the above CA Scheme through RTGS Account No. 000505025579/MADHYAPRADESH CAMPA for amount of Rs. 39173123.00/- dated 21.02.2018
4. Compliance has been done by user agency the cost of Medical Plantation has been transferred to CAMPA fund via e-portal for amount of Rs 2461165.00/- UTR no for amount is RTGS Account No. 000505025579/MADHYAPRADESH CAMPA dated 21.02.2018
5. Compliance has been done.
6. NPV has been submitted via e Portal amount of Rs. 24687562/- UTR No for amount is RTGS Account No. 000505025579/MADHYAPRADESH CAMPA dated 21.02.2018
7. All funds has been transferred as unfunded via e-portal.
8. The user agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter no. 7-25/2012-FC dated 05/05/2014 and 19/11/2014.
9. The right of people allotted under FRA 2006 has been settled and the certificate has been received from concerned District collector.
10. Felling of trees :
User agency agreed that Project shall restrict the felling of trees up to 768 trees in the diverted forest land. The trees shall be felled under strict supervision of the State Forest Department and only those trees shall be felled which are absolutely essential for the project.
11. As per the provisions of the Environmental (Protection) Act, 1986, not required for the transmission be.
12. User agency agreed that sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the laborers after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
13. User agency agreed that the boundary of the diverted forest land shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar.
14. User agency agreed that the period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.

15. User agency agreed that the User Agency shall ensure that because of this project, no damage is caused to the Wildlife.
16. User agency agreed that the user agency shall install circuit breakers at suitable places besides maintaining necessary ground clearances to prevent electrocution of Wild Animal.
17. User agency agreed that user agency will provide at its cost suitable bird deflectors, which are to be fixed on upper conductor of transmission line at suitable interval to avoid bird hit.
18. User agency agreed that Muck disposal and Soil conservation measures if required, shall be taken up as per the scheme approved by the Forest Department.
19. User agency agreed that no labour camp shall be established on the forest land.
20. User agency agreed that proposed labour camps outside the forest area, are to be dismantled and removed. The laborers shall be sent back immediately after the completion of the work.
21. User agency agreed that it will be the responsibility of the User Agency to ensure that the laborers and staff engaged in construction activity do not damage forest flora and fauna.
22. User agency agreed that no additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
23. User agency agreed that the forest land shall not be used for any purpose other than that specified in the project proposal.
24. User agency agreed that the layout plan of the proposal shall not be changed without prior approval of the Central Government.
25. User agency agreed that the forest land proposed to be diverted, shall under no circumstances be transferred to any other agencies, department or person without prior approval of Central Government.
26. User agency agreed that any other condition that the Ministry of Environment Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
27. User agency agreed that the user agency shall submit compliance report as on 1 st January to the Nodal Officer of the State.
28. User agency agreed that The State Government shall monitor compliance of conditions of Forest Clearance and shall submit in this regard yearly report as on 1st July of every year.
29. User agency agreed that the user agency and the State Government shall ensure compliance of provisions of the all Acts, rules, regulations and guidelines for the time being in force as applicable to the project.
30. The Compliance report will be uploaded on e- portal.

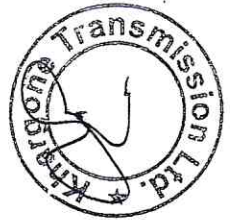
