Memorandum :-

This office has given an "In Principle" approval for diversion of 2.4354 ha of Protected forest land for laying of Optical Fiber Cable along From DCW circle nr Vijendra School (MS-1) Dhrangadhra to "T" junction of Kondh – Rampar Road Kondh Village on SH-7 & SH-119 (Km 23.0/Ha. 1.035) From Velavadar village to village Khodu ( KM5.62/ Ha 0.2529) From Lakhtar village "T" junction to Vana on SH-17 (KM-9/Ha 0.405) Total Km 37.620/Ha 1.6929 in Surendranagar District vide this office letter No No C/FCA/T.8/652-55/.Dt. 21/03/2018 referred above at (2)

The Relience Jio Infocom Ltd has reported that it has deposited an amount of Rs.12200/- towards the Cost of Registration Fee and processing Fee in the account of Govt. of Gujarat State Bank of India Gandhinagar .A/c No 66013423126 on Date 22.02.2018.The same has been confirmed by challan /bank receipt received

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act,1980, subject to the following conditions:-

1. The permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
3. The Relience Jio Infocom Ltd will have to obtain permission from this office for carrying out any maintenance works in future.
4. The Relience Jio Infocom Ltd will have make good the forest land after use/ maintenance work. No tree shall be cut.
5. The Relience Jio Infocom Ltd will be liable to make good any loss of Forests/Environment caused due to the use of the said land by the user agency.
6. The Relience Jio Infocom Ltd will seek permission from the Roads& Building Department/Science and Technology Department, Sachivalaya, Gandhinagar.
7. The Optical Fiber Cable.line will be laid underground in a trench of depth of 1 .65 Mtr and width of 0.45 Mtr.in between rows of road side plantation.
8. Any other condition, which the Nodal Officer (FCA) may stipulate from time to time.
