The Government of India vide Ref (1) have accorded 'in-principle' (Stage-I) approval for diversion of 0.986 hectare of forest land in Sy No. 178 of Khatak Chincholi village, Bhalki Taluk, Bidar District for construction of Water Treatment Plant, Laying of Water Pipeline and Approach Road in favour of the Executive

Engineer, Karnataka Urban Water Supply and Drainage Board, Bidar subject to fulfillment of certain conditions stipulated therein.

Based on Stage-I approval for the project, the Government of Karnataka vide Ref (2) has directed to submit the Compliance Report in respect of conditions of Stage-I approval.

Accordingly, this office vide Ref (3) has informed the User Agency and Field officers to submit the compliance report in respect of the conditions of Stage-I approval.

In response, the User Agency vide Ref (4) has submitted the compliance report to the Deputy Conservator of Forests, Bidar Division, who after verification has, vide Ref (5), submitted the condition-wise Compliance Report to the Chief Conservator of Forests Kalburgi Circle, who has further submitted the same vide Ref (6) to this office.
