विषयः जनपद मुजफ्फरनगर में भारतीय राष्ट्रीय राजमार्ग प्राधिकरण पी0आई0यू० बागपत द्वारा "Improvement to spur of NH-709AD Muzaffarnagar Bypass from Km 72+600 of NH-709AD to km 113+450 of NH 334 near Muzaffarnagar town (Design km 0+000 to km 10+135)" हेतु 5.597592 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग एवं बाधक विभिन्न प्रजातियों के 461 वृक्षों के पातन/ट्रान्सप्लान्ट की अनुमित के सम्बन्ध में।

महोदय,

उपरोक्त विषयक सचिव (वन), उ०प्र० शासन के पत्रांक पी–300/81–2–2022–800(300)/2022, दिनांक 31.08.2022 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रस्ताव पर वन(संरक्षण) अधिनियम, 1980 की धारा(2) के अन्तर्गत भारत सरकार की स्वीकृति मॉगी थी।

प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 02.11.2022 द्वारा सैद्धांतिक स्वीकृति प्रदान की गई थी, जिसकी अनुपालना उपरोक्त संदर्भित पत्र के माध्यम से प्रेषित की गई है। प्रेषित अनुपालना के परीक्षणोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार जनपद मुजफ्फरनगर में भारतीय राष्ट्रीय राजमार्ग प्राधिकरण पी0आई0यू0 बागपत द्वारा "Improvement to spur of NH-709AD Muzaffarnagar Bypass from Km 72+600 of NH-709AD to km 113+450 of NH 334 near Muzaffarnagar town (Design km 0+000 to km 10+135)" हेतु 5.597592 हे0 संरक्षित वनभूमि के गैरवानिकी प्रयोग एवं बाधक विभिन्न प्रजातियों के 461 वृक्षों के पातन/ट्रान्सप्लान्ट की विधिवत स्वीकृति निम्नलिखित शर्तों पर प्रदान करती है:—

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department in an area of 12.00 ha degraded forest land in Compartment/Survey No. 2b of Sahansara (Patli Milan) Block, Range Shakumbari, Shiwalik Forest Division, Saharanpur at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.
- 3. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 4. User agency shall restrict the felling of trees to 461 trees/minimum numbers in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the User Agency with the State Forest Department.
- 5. Plantation shall be raised on both sides of the road and median (if available) at the cost of User Agency according to IRC guidelines and order passed by NGT in OA no. 27/2015 in the matter of Babulal Jaju v/s State of Rajasthan and others dated 16.11.2015.
- 6. Speed regulating signage will be erected along the road at regular intervals in the Protected Areas/ Forest Areas.

- 7. The user agency shall provide suitable under / over pass in Protected Area / Forest Area as per recommendations of CWLW / NBWL / FAC / REC.
- 8. The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- 9. The layout plan of the proposal shall not be changed without prior approval of Central Government.
- 10. No labour camp shall be established on the forest land.
- 11. Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- 12. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- 13. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 14. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 15. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 16. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 17. The KML file of the area to be diverted, the CA areas, the proposed SMC work, the proposed Catchment Area Treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details before commencement of works
- 18. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
- Project Completion Report and Stage-II compliance report shall be submitted within a period of 6 months of completion of project.
- 20. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- 21. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
