I am to enclose herewith a copy of the letter cited along with statutory proforma proposal under Forest (Conservation) Act, 1980, submitted by the Principal Chief Conservator of Forests (Head of Forest Force), Andhra Pradesh for diversion of 2.355 Ha. of forest land in Compt.No.284 of Basivireddipalle Extn. 'B' RF of Palamaner Range of Chittoor West Division for formation of Reservoir across Gangamma Sirassu Vanka near Nalagampalle (V) Palamaner (M) including diversion system in favour of Executive Engineer, Irrigation Department, Palamaner.


2. I wish to inform that the user agency i.e. the Executive Engineer, Irrigation Department, Palamaner has submitted justification stating that the area proposed for diversion is for formation of Reservoir across Gangamma Sirassu Vanka and there is no alternative suitable location in non forest land was available and the area required for the project is barest minimum area for the purpose for which it is proposed. The User Agency has submitted an undertaking to bear the cost of raising and maintenance of Compensatory Afforestation, Payment of Net Present Value (NPV), additional NPV and tree extraction charges etc.

3. The District Collectors, Chittoor District has issued necessary certificates under scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, as stipulated by the Ministry of Environment, Forests & Climate Change, Government of India, New Delhi vide Lr.No.11-9/1998-FC (pt), Dt.05.07.2013, in the prescribed format Annexure-I (Form-II) for evidences for having initiated and completed the process of settlement of rights. The field officers concerned and the Principal Chief Conservator of Forests (Head of Forest Force), have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in the proforma proposal in Part-V is enclosed herewith.

I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, under section 2 of Forest (Conservation) Act, 1980, for diversion of 2.355 Ha. of forest land in Compt.No.284 of Basivireddipalle Extn. 'B' RF of Palamaner Range of Chittoor West Division for formation of Reservoir across Gangamma Sirassu Vanka near Nalagampalle (V) Palamaner (M) including diversion system in favour of Executive Engineer, Irrigation Department, Palamaner, at an early date.
