
This is a Proposal for diversion of 0.0144 hectares of Forest Land under Kalimpong Forest Division in favour of the Reliance Jio Infocomm Limited for setting up e-Node (Mobile Tower) at Mongpong 10 compartment under Kalimpong Forest Division.

The proposal has been recommended by the Divisional Forest Officer, Kalimpong Forest Division and the Chief Conservator of Forest, Hill Circle, West Bengal.

Therefore, the proposal for diversion of 0.0144 hectares in favour of Reliance Jio Infocomm Limited is recommended for 30 years for installing above Mobile Tower, subject to FRA Certificate from District Magistrate Kalimpong being furnished. CA should be for 100 trees which is the minimum as per rules.


