**MEMORANDUM**

This office has given an "In Principle" approval for diversion of **1.1925 Ha.** of Protected Forest Land for grant permission for laying Optical Fiber Cable along the routes mentioned above subject in favour of **Reliance Jio Infocomm Ltd., Ahmedabad** vide the Office of the Deputy Conservator of Forests, Social Forestry Division, Nadiad reference at Sr.No.(2) above.

The User Agency has reported that it has deposited an amount of **5000/-** towards **Registration fee**, an amount of **2,400/-** towards **Processing fee** on the account of Government of Gujarat. GoG issue Challan for **8782-Forest Remittance Head** through State Bank of India, Main Branch, Nadiad on **Dt.09/03/2017**. The FRA certificate has been issued by Collector Kheda is submitted by User Agency on Dt.04/02/2020.

The undersigned is pleased to convey the "Formal Approval" of the Government under section-2 of the Forest (Conservation) Act. 1980, subject to the following conditions :-

- (1) The permission is granted only for use of the Forest Land for the purpose specified in the proposal. The legal status of the Forest Land shall remain unchanged.
- (2) The Forest Land shall not be used for any purpose other than that specified in the FCA proposal.
- (3) The User Agency will have to obtain permission from this office for carrying out any maintenance works in future.
- (4) The User Agency will have to make good the Forest Land after use/ maintenance work.  
**No tree shall be cut.**
- (5) The User Agency will be liable to make good any loss to Forests/ Environment caused due to the use of the said land by the user agency.
- (6) The Optical Fiber Cable line will be laid underground in a trench of depth of 2.00 meters and width of 1.00 meter, in between rows of road side plantation.
- (7) The User Agency will seek permission from the Road & Building Department/ Science & Technology Dept., Sachivalaya, Gandhinagar.
- (8) Any other condition, which the Nodal officer (FCA)/the State Government may stipulate from time to time.
