The user agency needs to upload the demand notice against the project for approval by Nodal Officer (FCA), Telangana and generate challan after approval. Further, the User Agency is requested to comply with the following accordance with the GOI, MoEF&CC, New Delhi vide F.No.7-23/2012-FC, dt:24.07.2013 communicated vide PCCF's Rc.No.45921/2001-F4, dated:23.08.2013 and publish the orders at the cost of the project proponent.

1. Publish the entire forest clearance granted to the project proponent for the use of forest land for the non-forest purpose in verbatim along with the condition(s) and safe-guards imposed by the Central Government in two widely circulated daily news papers i.e., one is vernacular language and the other in English.

2. The copies of the Forest Clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in-turn has to display the same for 30 days from the date of receipt of this reference..

Further, the user agency is requested to furnish compliance report along with all the required relevant information/documents etc., as stipulated in Stage-I approval and other conditions at the earliest, so as to submit the condition wise compliance report to the higher authorities for obtaining Stage-II approval. The User Agency is informed that the transfer of forest land to User Agency shall not be affected prior to the issue of final approval of Stage-II clearance(or) working permission whichever is earlier and no work in violation shall be carried out.
