With reference to the above subject, the undersigned has submitted the information [as sought by the Government of India] with respect to diversion of 4.85 ha of forest land in North Eastern Block (NEB) Forest (near Karadikolla Village), Sandur Taluk, Ballari District for approach road to mining lease No.2487 (an e-auctioned C-category mine of erstwhile FC holder M/s. Laksmi Narayana Mining Company) in favour of the successful bidder i.e. M/s.MSPL Ltd, Hospete vide letter under Ref(1).

Further, upon verification of the records available, you have remitted Compensatory Afforestation charges of Rs. 89,04,600.00 (Rs.18,36,000/- per ha) for an extent of 4.85 Ha.

It is observed that, Compensatory Afforestation charges has been revised to Rs. 19,45,000/ per ha vide letter under Ref(3). Therefore, the you have to remit differential CA charges for this instant proposal.
