The financial outlay for Compensatory Afforestation Scheme over an area of 1086.993 ha of degraded forest land (586.0 ha plantable area) identified in Nayagarh Forest division pertaining to the above project has been approved by CCF (FD & Nodal Officer, FC Act) as per approved one time cost norm for Rs 18,59,21,700/- (Rupees eighteen crores fifty nine lakhs twenty one thousand and seven hundred) only is enclosed.

I am directed to enclose herewith the copy of 'Stage-I/ in-principle' approval order of Government of India, MoEF&CC, IRO, Bhubaneswar vide letter No.5-ORA528/2022-BHU, dt.13.02.2023 for diversion of 594.618 ha (292.289 ha in Nayagarh Forest Division and 302.329 ha in Boudh Forest Division) of forest land in connection with Khurda-Bolangir New BG Rail Link Project 112 Km to 180 Km under Nayagarh and Boudh Forest Division by East Coast Railway for which proposal was forwarded by the State Government to Government of India, MoEF&CC, IRO, Bhubaneswar vide letter No.15657/FE&CC dtd.05.09.2022. The Stage-I approval order referred to above indicates that Government of India, MoEF&CC, agrees 'in-principle' for diversion of 594.618 ha (292.289 ha in Nayagarh Forest Division and 302.329 ha in Boudh Forest Division) of forest land in connection with Khurda-Bolangir New BG Rail Link Project 112 Km to 180 Km under Nayagarh and Boudh Forest Division by East Coast Railway subject to compliance of conditions as laid down therein so as to consider the case for Stage-II (Final) forests clearance.

It is requested to take necessary steps for compliance of the conditions imposed in the Stage-I/ in-principle approval order of MoEF&CC, Govt. of India, IRO, Bhubaneswar. Appropriate instruction in this context may be imparted to the Divisional Forest Officer, Nayagarh Forest Division and Divisional Forest Officer, Boudh Forest Division as well as to the user agency for compliance of the conditions. Detailed compliance of all the conditions imposed by MoEF&CC, IRO, Bhubaneswar may be meticulously scrutinized by PCCF (Forest Diversion & Nodal Officer, FC Act) of your office and further necessary steps may also be taken by him expeditiously to furnish the detailed compliance in this respect to MoEF&CC, on behalf of State Government as per authorization of State Government communicated in this regard vide letter No.10195/F&E dtd.16.05.2017 to you, for their consideration for according final forest clearance for this proposal. A copy of detailed compliance so sent to MoEF&CC, IRO, Bhubaneswar may also be furnished to State Forest, Environment & Climate Change Department unfailingly for reference.

Since it is a linear project and as per IRO, MoEF&CC, Govt. of India order (last para), the Divisional Forest Officer, Nayagarh Forest Division and Divisional Forest Officer, Boudh Forest Division may take further follow up action in compliance as per Para 11.2 of Chapter-11 of Handbook of Guidelines issued under F.C. Act, 1980 vide Ministry's letter No.5-2/2017-FC dtd.28.03.2019 and as per the orders of the State Government in F&E Department communicated vide Memo No.17194/F&E dtd.28.09.2015 for allowing the User Agency to undertake project activities on forest land, being diverted, for a period of one year pending Stage-II forest clearance. Required instructions in this context may be imparted to the DFOs concerned for placing demand with the User Agency for deposit of all the Compensatory levies pertaining to this project. Commencement of project activities shall however be subject to availability of other statutory clearances, as may be required for this project.

Violation of Forest Conservation Act, 1980, if any, may, however, be reported in detail expeditiously to the State Government as per Para 1.21 of Chapter-1 of the Handbook of Comprehensive Guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dtd.28.03.2019 for bringing the same to the notice of Government of India, Ministry of Environment, Forests and Climate Change for further action at their end.

Madam,

I am directed to refer to State Govt. letter No.FE-DIV-FLD-0071-2022-15657/FE&CC dated 05.09.2022 and PCCF&HoFF, Odisha's letter No.24041/9F(RLY)-413/2021 dated 28.11.2022, No.24486/9F (Fly)-413/2021 dated 03.12.2022 & No.26190/9F(Rly)-413/2021 dated 27.12.2022 on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under section 2 of Forest (Conservation) Act, 1980.

2. After due consideration of the proposal of the State Government and on the basis of decision of Regional Empowered Committee meeting held on 09.02.2023, the Ministry of Environment, Forest & Climate Change hereby conveys 'Stage-Lin-principle' approval for diversion of 594.618 ha (292.289 ha in Nayagarh Forest Division and 302.329 ha in Boudh Forest Division) of forest land in connection with Khurda-Bolangir New BG Rail Link Project 112 Km to 180 Km under Nayagarh and Boudh Forest Division by East Coast Railway, subject to the fulfillment of the following conditions.

A: Conditions which need to be complied prior to handing over of forest land by the State Forest Department.

- The Project Proponent shall ensure the compliance of order dated 16.01.2023 passed by the Hon'ble Supreme Court of India in IA No. 160201 of 2022.
- ii) The user agency shall transfer online, the Net Present Value (NPV) of 594.618 ha forest land being diverted under this proposal, as per the Orders of Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No.202/1995 and the guidelines issued by this Ministry vide its letter No.5-3/2011-FC (Vol-I) dated 06.01.2022 and 19.01.2022. The requisite funds shall be transferred through online portal in CAMPA account of the State concerned.
- iii) The degraded Revenue forest of 606.00 ha identified in Boudh Forest Division for raising compensatory afforestation shall be transferred and mutated in the name of Forest Department and notified as RF/PF prior to Stage-II approval.
- iv) A Comprehensive Wildlife Management Plan should be prepared addressing all the issues not only for safety of elephant but also for all the wildlife found in the locality duly approved by CWLW.
- v) The land identified for the purpose of Compensatory Afforestation shall be clearly depicted on a Survey of India Topo sheet of 1:50,000 scale.
- vi) The KML files of the area to be diverted and the CA areas shall be uploaded on the e-Green watch portal with all requisite details before issuing working permission towards linear projects or submitting compliance report for seeking Stage-II approval, as the case may be.
- vii) The user agency shall transfer the cost of raising and maintaining the compensatory afforestation at the current wage rate in consultation with State Forest Department in the

- account of CAMPA of the concerned State through online portal. The Scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.
- viii) All the funds received from the user agency under the project shall be transferred/deposited in CAMPA account only through e-portal (https://parivesh.nic.in/). Amount deposited through other mode will not be accepted as compliance of the Stage-I clearance.
- ix) The compliance report of the Stage-I approval shall be uploaded on e-portal (https://parivesh.nic.in/).
- x) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- xi) The boundary of the proposed forest land for diversion, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, distance from pillar to pillar and GPS co-ordinates.
- B: Conditions which need to be strictly complied on field after handing over of forest land to the user agency by the State Forest Department but the compliance in form of undertaking shall be submitted prior to Stage-II approval.
 - Legal status of forest land proposed for diversion shall remain unchanged.
 - ii) Compensatory afforestation shall be raised over 1192 ha degraded forest land identified in Nayagarh Forest Division (586.00 ha) and Boudh Forest Division (606.00 ha) within three years from the date of Stage-II Clearance and maintained thereafter by the State Forest Department as per approved plan/scheme and maintained thereafter, at the cost of user agency. The species to be planted in the CA scheme shall be of native species of the area. At least 18 month old seedlings should be planted. Intensive monitoring of the plantation needs to be done and documented using Geo tagging so that the increase of canopy density and survival and growth of plantation can be evaluated at regular intervals.
 - iii) At the time of payment of Net Present Value (NPV) at the then prevailing rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.
 - iv) As the proposed railway line is in the elephant impact zone and elephant corridor, so elephant overpasses, underpasses and viaducts at appropriate positions as identified by the local Divisional Forest Officer should be constructed, fencing of the railway line towards the sanctuary side should be done so that elephant will not enter the track and will use the under passes and overpasses.
 - v) Speed of the train should be less than 20 KM per hour in the stretch and Forest Department/ Railway Authority should regularly inform each other regarding the movement of elephant so that the train can be stopped without harm to elephants as and when required.
 - vi) Speed regulating signage will be erected along the railway line at regular intervals in Protected Areas/Forest Areas.
 - vii) The user agency shall take up Avenue Plantation on either side of alignment of the track at its own cost in consultation with the DFO.
 - viii) The user agency shall obtain Environment Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
 - ix) No labour camp shall be established on the forest land and the user agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
 - No additional or new path will be constructed inside the forest area for any activity related to the project work.
 - xi) The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.
 - xii) The layout plan of the proposed forest land shall not be changed without the prior approval of Ministry of Environment, Forest & Climate Change.
 - xiii) The forest land shall not be used for any purpose other than that specified in the proposal.

- xiv) The forest land proposed to be diverted shall under no circumstances be transferred to any other user agency, department or person without the prior approval of Ministry of Environment, Forest & Climate Change.
- xv) No damage to the flora and fauna of the adjoining area shall be caused.
- xvi) The concerned Divisional Forest Officer, will monitor and take necessary mitigative measures to ensure that there is no adverse impact on the forests in the surrounding area.
- xvii) The user agency shall explore the possibility of successful transplantation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under strict supervision of the State Forest Department.
- xviii) The user agency shall submit annual self monitoring report on compliance of stipulated conditions to the Nodal Officer (FCA) of the State and concerned Integrated Regional Office of this Ministry by the end of March every year.
- xix) Any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency.
- xx) The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.
- xxi) Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in Para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.
- 3. After receipt of the report on compliance to the conditions stipulated above, from the State Government of Odisha, final/Stage-II approval for diversion of the said forest land under Section 2 of Forest (Conservation) Act, 1980 will be issued by this Ministry. Transfer of forest land to user agency should not be effected by the State Government of Odisha till final/Stage-II approval for its diversion is issued by the Ministry of Environment, Forest & Climate Change.
- 4. "The State Govt. or a Senior Office not below the Rank of a Divisional Forest Officer, having jurisdiction over the forest land proposed to be diverted, duly authorized in this behalf by the State Govt. can pass an order for tree cutting and commencement of work of a linear project in forest land for a period of one year. Such order shall be passed only after full realization of funds for compensatory afforestation, Net Present Value (NPV), Wildlife conservation Plan, plantation of dwarf species of medicinal plants, and all other compensatory levies, specified in the Stage-I (in-principle) approval from the User Agency, and where ever applicable, transfer and mutation of non-forest/revenue forest land in favour of State Forest Department" as stipulated in Para 11.2 of Chapter-11 of Handbook of Guidelines issued under F.C. Act, 1980 vide Ministry's letter No.5-2/2017-FC dated 28.03.2019.
