उपरोक्त विषयांकित में संदर्भित पत्र का आशय ग्रहण करते हुए सूचित करना है कि राज्य सरकार द्वारा सैद्धान्तिक स्वीकृति (Stage-I Approval) पत्र की शर्त संख्या 7,18 एवं 28 की अनुपालना रिपीर्ट Part-II, Para 4 ()) एवं (II) में उल्लेखित विवरण ते बेमेल (mismatch) पाई गई हैं । अतः राज्य सरकार उक्त शर्तों की प्रस्तृत अनुपालन रिपीर्ट के अनुसार परिवेश पीर्टल पर सही जानकारी अपलोड (upload) करने के साथ निम्नलिखित अतिरिक्त विदुओं पर भी विधिवत स्वीकृति से पूर्व अनुपालना रिपीर्ट एवं बांछित राशी (यदि आवश्यक हो) निर्धारित कोथ में अमा करना सुनिश्चित करें ताकि प्रस्ताव पर आगामी कार्यवाही की जा सके:-

- In respect of the compliance of condition 7 of in-principle approval, NPV has been calculated @ of 10, 69,470 / ha has been charged according to the Eco- Class VI (Open Forest) and the same has been deposited in the account of CAMPA FUND. However, the correct Eco-Class has not been revised/updated on PARIVESH Portal accordingly. Therefore, State Govt. may update Para -4 (i) of Part-II on PARIVESH Portal accordingly.
- Regarding the compliance of condition no. 18 and 28 of in-principle approval, the 615 trees
  including 44 trees standing over dumping sites are being affected. However, Para-4 (ii) of Part-II
  shows that 659 trees are being affected. Therefore, State Govt. may update the same on
  PARIVESH Portal accordingly.
- According to Part-II, Para-6 Brief note on the vulnerability of the forest area to erosion, it is mentioned that there forest area is not vulnerable. However, the project is being established on the hilly terrain and a large number of trees (615 trees) of different species are being affected and the forest/adjoining area may prone to accelerated soil erosion during/ after execution of the project. Therefore, State Govt. may submit the Soil and Moisture Conservation Plan along-with

cost of its implementation in to account of CAMPA before Stage-II approval, if required, as the recent directions of MoEF & CC vide latter dated 7.6.2022. However, in cases where it is of possible for the State Govt. to submit the compliance due to delay in preparation of such plan, a sump sum amount of 0.5% of the project cost shall be realized from the User Agency and submitted before Stage-II approval. The deficit amount, as per the said plan, if any, from the money already realized to the tune of 0.5% of the project cost shall be deposited in CAMPA account prior to actual working on the forest area.

Part-II, Para-8 shows that some important Wildlife species are found in and around the area proposed for diversion. Therefore, State Govt. may submit the Wildlife Management Plan alongwith detail cost of its implementation in to account of CAMPA before Stage-II approval, if required, as per the recent directions of MoEF & CC vide latter dated 7.5:2022. However, in cases where it is not possible for the State Govt. to submit the compliance due to delay in preparation of such plan, a lump sum arount of 2% of the project cost shall be realized from the User Agency and submitted before Stage-II approval. The deficit amount, as per the said plan, if any, from the money already realized to the tune of 2% of the project cost shall be deposited in CAMPA account prior to actual working on the forest area.
