With reference to the captioned subject cited, it is to inform you that, you have already deposited the Compensatory Afforestation Scheme amount of Rs. 94, 25,200/- (Rupees Ninety-four lakh twenty-five thousand two hundred) only through e-portal on dated 08.03.2022 in the old wage rate @ Rs.315/MD. In the mean while Govt. has enhanced the wage rate @ Rs.333/MD w.e.f. as per Notification No. 6078 dated 01.10.2022 of the Labour Commissioner, Odisha. Now, the revised Compensatory Afforestation amount comes for Rs. 10443700/- (Rupees One crore four lakh forty-three thousand seven hundred) only as per wage rate of 333/MD with provision of planting of 18 months seedlings.

You are, therefore, requested to deposit the balance Compensatory Afforestation amount of Rs. 1018500/- i.e. (Rs. 10443700 - Rs. 9425200= Rs. 1018500/-) through e-portal immediately and report the fact of deposit to the undersigned for taking further action at this end.


