ORDERS BY THE GOVERNOR: MANIPUR Imphal, the 26th August, 2016.

No.20/21/2015-For&Envt: In pursuance of the letter F.No. 11-9/98-FC dated 13/2/2014 MoE&F, Government of India and letter No.7/129/2015/Forests/195-98 dated 27/7/2016 of Pr. Chief Conservator of Forest, Manipur, the Governor of Manipur is pleased to accord final approval under section 2 of the Forest (Conservation) Act 1980 for the diversion of 0.1318 ha of forest land for construction of RCC tunnel for conveyance of water along the right main canal of Dolaithabi Project, Manipur subject to the following conditions:-

1. The legal status of the forest land shall remain unchanged.

2. User Agency shall provide the required undertaking that no tree felling is allowed in the diverted forest area other than those proposed by the User Agency in their Application under Section-2 of FC Act,1980.

3. User Agency shall provide the required undertaking that the requirement of forest land for the proposal shall not exceed the barest minimum duly certified by the concerned Divisional Forest Officer.

4. Nodal Officer, FCA, Manipur shall submit monthly report to the Regional Office of the MoEF & CC, North East Regional Office, Shillong.

5. User Agency shall provide the required undertaking to plant indigenous tree species numbering one hundred in consultation with the DFO,Central Forest Division in the vicinity and the planted trees shall belong to the State Forest

6. User Agency shall provide the required undertaking that it shall be responsible for any loss of flora and fauna in the surrounding area and therefore, shall take all possible measures to conserve the same.

7. The User Agency has transferred Rs.96,214/-(Rupees ninety six thousand two hundred and fourteen)only as cost of NPV to the CAF, Manipur Account No. 037100101025219 of Corporation Bank, CGO Complex, New Delhi through NEFT Vide UTR No. UTBIN1607757179 dated 17/03/2016 being the cost of the Net Present Value (NPV)/additional Net Present Value for the diverted forest land as established by law.

8. The general approval granted by the State Government shall be subject to the monitoring by the concerned Regional Office of the Ministry of Environment, Forest & Climate Change, Government of India, Shillong.

9. User Agency shall provide the required undertaking that forest land shall not be used for any purpose other than that specified in the proposal. Any change in the land use without prior permission of the Central Government shall amount to the violation of Forest (Conservation) Act,1980.

User Agency shall provide the required undertaking that it shall comply with the conditions that the Forest Department/State Forest Department or the North Eastern Regional Office,MoEF&CC, Government of India,Shillong may impose from time to time in the interest of conservation/protection and/or development of forests.
- 11. User Agency shall provide Site-map of the proposed Engineering works on a scale of 1:50,000 showing important corner points with GPS Co-ordinates.
- 12. Certificate on Recognition of Forest Rights Act, 2006 issued by ADC Kangpokpi should be submitted along with the project proposal.
- 13. The proposed forest land is not yet handed over to User Agency, before submission of full compliance.
