
Sub: GCC II/Chennai – Forest (Conversion) Act, 1980 – Online proposal submitted by TANGEDCO for diversion of 5.06 Ha (now revised to 3.85 Ha) of forest land in Thirutheri RF Chengalpattu Range for erection of 230 KV DC Transmission line from Cuddalore to Veerapuram (S.P. Koil) viz Neyveli – Complaine report submitted – Regarding.

1. As per instruction of District Forest Officer, Kancheepuram vide ref (3) cited above, an amount of Rs.1,68,23,565/- (Rupees One crore sixty eight lakhs twenty three thousand five hundred and sixty five only) has been remitted on 13.02.2020 under the Tamil Nadu CAMPA by generating online challan through e-portal (PARIVESH) towards CA scheme and NPV.
2. Further the demand draft for an amount of Rs.42,570/- has been drawn in favour of District Forest Officer, Chengalpattu Division, Kancheepuram and enclosed herewith towards expected yield of 268 number of trees to be felled.
3. In continuation to above, the detailed complaine report in accordance with letter cited in ref (2), has been submitted herewith for favour of further action.
4. It is submitted that the erection of this 230 KV transmission line from Cuddalore – Veerapuram is funded by KFW Bank, German Country which is in grant till 30.03.2020 only. Hence, the work has to be completed within the stipulated period failing which the grant will be converted as loan which would be a huge burden to our state. Further the scheme is being monitored very closely in our Prime Minister Review.

5. In the light of above, it is requested that the necessary permission to commence the work may kindly be granted by the competent authority at the earliest please.



The User Agency in consultation with the State Forest Department shall prepare and implement a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal plants) in the right of way under the transmission line at its cost;	Will be done after completion of work.
