
I enclose herewith a copy of the letter cited along with statutory proforma proposal under Forest (Conservation) Act, 1980, submitted by the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh for diversion of 101.24 Ha. of forest land is located in Compt.No.571, 572, 573, 575 of Ganganapalli RF of Kadapa Division for excavation of GNSS Phase-II Main Canal from KM 87.40 to KM 94.80 under Package No.02/06 in favour of Executive Engineer, GNSS Division No.7, Pulivendula, Y.S.R. District.

2. I wish to inform that the user agency i.e. Executive Engineer, GNSS Division No.7,Pulivendula, Y.S.R. District has submitted justification stating that the area proposed for diversion is for earth work excavation of GNSS Main canal and there is no alternative suitable land is available other than the proposed area and the area required for the project is barest minimum area for the purpose for which it is proposed. The User Agency has submitted an undertaking to bear the cost of raising and maintenance of compensatory afforestation, payment of Net Present Value (NPV), additional NPV and tree extraction charges etc. The Principal Chief Conservator of Forests has reported that the user agency has not violated the provisions of Forest (Conservation) Act, 1980.

3. The District Collector, YSR Kadapa has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006, as stipulated by the Ministry of Environment, Forests & Climate Change, Government of India, New Delhi vide Lr.No.11-9/1998-FC (pt), Dt.05.07.2013, in the prescribed format (Form-II) for evidences for having initiated and completed the process of settlement of rights. The field officers concerned and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in the proforma proposal in Part-V is enclosed herewith.

I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forests & Climate Change, under Section 2 of Forest (Conservation) Act, 1980, for diversion of 101.24 Ha. of forest land is located in Compt.No.571, 572, 573, 575 of Ganganapalli RF of Kadapa Division for excavation of GNSS Phase-II Main Canal from KM 87.40 to KM 94.80 under Package No.02/06 in favour of Executive Engineer, GNSS Division No.7, Pulivendula, Y.S.R. District, at an early date.
