विषयः जनपद हापुड़ के अन्तर्गत ग्राम बागडपुर, तहसील गढ़मुक्तेश्वर के खसरा संख्या—1643, राष्ट्रीय राजमार्ग 24 के किमी0 92.03 से किमी0 92.068 तक हिन्दुस्तान पेट्रोलियम कार्पो0 लि0 द्वारा प्रस्तावित नवीन रिटेल आउटलेट के सम्पर्क मार्ग के निर्माण हेतु 0.2544 हे0 (Entry Area = 0.0575 ha. + Exit Area = 0.0669 ha. + Separator island = 0.1300 ha, Total area is 0.2544 ha.) संरक्षित वनभूमि एवं विभिन्न प्रजातियों के 29 वृक्षों के पातन के गैर वानिकी प्रयोग की अनुमति के सम्बन्ध में।

महोदय,

कृपया उपरोक्त विषयक सचिव (वन), उत्तर प्रदेश शासन के पत्रांक पी–3584 / 81–2–2023–800(231) / 2023, दिनांक 29.09.2023 का आशय ग्रहण करने का कष्ट करें, जिसके द्वारा विषयांकित प्रकरण में राज्य सरकार द्वारा वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 के अन्तर्गत भारत सरकार की स्वीकृति मांगी गयी थी।

प्रकरण में इस कार्यालय के समसंख्यक पत्र दिनांक 15.05.2024 द्वारा कितपय शर्तों के साथ सैद्धांतिक स्वीकृति प्रदान की गयी थी, जिसकी अनुपालना उपरोक्त संदर्भित पत्रों के माध्यम से प्रेषित की गई है। प्रस्तुत अनुपालना के परीक्षणोपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि केन्द्र सरकार जनपद हापुड़ के अन्तर्गत ग्राम बागडपुर, तहसील गढ़मुक्तेश्वर के खसरा संख्या—1643, राष्ट्रीय राजमार्ग 24 के किमी0 92.03 से किमी0 92.068 तक हिन्दुस्तान पेट्रोलियम कार्पोo लि0 द्वारा प्रस्तावित नवीन रिटेल आउटलेट के सम्पर्क मार्ग के निर्माण हेतु 0.2544 हे0 (Entry Area = 0.0575 ha. + Exit Area = 0.0669 ha. + Separator island = 0.1300 ha, Total area is 0.2544 ha.) संरक्षित वनभूमि एवं विभिन्न प्रजातियों के 29 वृक्षों के पातन के गैर वानिकी प्रयोग की विधिवत् स्वीकृति निम्नलिखित शर्तों के साथ प्रदान करती है:—

- 1. Legal status of the forest land shall remain unchanged.
- 2. Compensatory afforestation shall be taken up by the Forest Department in an area of 0.5088 ha. Degraded Forest Land in Compartment No 1, Village Alamgirpur Forest Block, Range Garhmukteshwar, District Hapur at the cost of the user agency. At least 290 plants shall be planted in the said DFL. As far as practicable a mixture of local indigenous species will be planted and monoculture of a species has to be avoided.
- 3. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- 4. User agency shall restrict the felling of trees to the enumerated 29 trees/ any minimum number in the diverted forest land and they shall be felled under the strict supervision of the State Forest Department or the cost of felling of trees shall be deposited by the User Agency with the State Forest Department and the State Forest Department shall undertake the fellings.
- 5. Layout plan of the proposal shall not be changed without prior approval of the Central Government.
- 6. No labour camp shall be established on the forest land.
- 7. Separator island has to be maintained as Green Belt, in consultation with the DFO. Green belt plan on separator island shall be approved by the DFO, ensuring appropriate site specific species. Green belt plan shall also include species to be planted on the periphery of retail outlets and service road, if applicable.
- 8. Annual Compliance report regarding maintenance of Green belt on separator island along with geo tagged photographs as per approved green plan to be submitted through the DFO to Nodal officer and Regional Office, MoEFCC.
- 9. Entire periphery of the establishment should be lined up with plantation at a close spacing of 1.0 to 1.5 meter keeping an offset of 1.5 meter from the boundary, with light crown tree species which will maintain greenery without compromising with the land requirement of the establishment.

- 10. User Agency and authorized signatory oil company issuing sanction letter shall be liable for land use including tree plantation for entry/exit and Separator island strictly as per the approved layout plan and any violation/ non adherence shall attract penal action/ prosecution in competent court of jurisdiction as per Van (Sanrakshan Evam Samvardhan) Adhiniyam, (1980), Rules and guidelines.
- 11. User Agency shall implement green plan at their cost as approved by the DFO. User Agency shall maintain geo tagged photographs of planted trees. Six monthly geo tagged photographs of plantations shall be maintained and a report be submitted to the DFO and also made available at site of retail outlet for inspection. Any mortality of trees shall be replaced by a new plant.
- 12. The User Agency shall provide alternate fuels preferably LPG to the labourers and staff working at the site so as to prevent any damage and pressure on the nearby forests.
- 13. The separator island will be provided in front of Fuel Station between acceleration and declaration lanes and the space shall be used for plantation and its boundary shall be demarcated by a 2 ft. wall.
- 14. Plantation shall also be done along the inside boundary of the Fuel Station.
- 15. Greenery will be maintained by the user agency around the periphery of Retail outlet.
- 16. Boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per directions of the concerned Divisional Forest Officer.
- 17. No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- 18. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- 19. The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.
- 20. The forest land shall not be used for any purpose other than that specified in the project proposal.
- 21. The KML file of area proposed for diversion and area proposed for plantation shall be uploaded on the E-Green watch portal with all requisite details before commencement of works.
- 22. Annual 3rd party monitoring and concurrent internal monitoring by the State Forest Department shall be done and monitoring reports submitted to this office.
- 23. The User Agency and the State Government shall ensure compliance of all the Court orders, provisions, rules, regulations and guidelines for the time being in force as applicable to the project.
- 24. Project Completion Report and Stage-II compliance report shall be submitted within a period of 6 months of completion of project.
- 25. Violation of any of the conditions stipulated under this approval will be liable for cognizance and appropriate action under MoEFCC rules and Guidelines as applicable, specifically MoEFCC Guidelines dated 15/05/2023, authorizing officers of the rank of Divisional Forest Officer (DFO)/Deputy Conservator of Forests (DCF) and above of the State Government or Union territory Administration concerned, having jurisdiction over the forest land in respect of which any offence under the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 is committed or violation of the provisions of the said Adhiniyam has been made, to file complaints against such person/authority/organization, prima-facie found guilty of offence under the Adhiniyam or the violation of the rules made thereunder, in the court having jurisdiction in the matter.
- 26. Violation of any of these conditions will amount to violation of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per the MoEF&CC Guideline.
- 27. Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.
