

- We hereby agree and give undertaking that the legal status of the forest land shall remain unchanged as the permission is granted only for use of Forest Land for the purpose as specified in the proposal.
- We hereby agree and give undertaking that the Forest Land will be utilized for the project work only after required double degraded Forest land for the project is handed over.
- We hereby agree and give undertaking that the C.A. at prevailing wage rate as per C.A. Scheme, the amount Rs.1,72,05,240/- has been deposited online in CAMPA Fund.
- We hereby agree and give undertaking that the NPV charges for 20.00 ha. as per order of Hon'ble Supreme Court, online NPV amount Rs. 87,60,000/- for the area to be diverted has been paid. Any additional amount of the NPV of the diverted land, if due after finalization of the same shall be paid by this office.
- We hereby agree and give undertaking that felling of trees upto 1124 no's in the diverted forest land under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by us.

- We hereby agree and give undertaking that all the funds demanded has been deposited in CAMPA Fund through e-portal.
- We hereby agree and give undertaking that the Certificate of Collector under FRA-2006 has been submitted and uploaded.
- We hereby agree and give undertaking that we shall raise strip plantations on both sides and central verge of the road as per the IRC Norms.
- We hereby agree and give undertaking that speed regulating signage will be erected along the road at regular intervals in Forest Area wherever required.
- We hereby agree and give undertaking that we shall provide suitable measure for free movement of wildlife in and around the Forest Area (If Any)
- We hereby agree and give undertaking that the layout plan of the proposal shall not be changed without prior approval of the Central Government.
- We hereby agree and give undertaking that no labor camp shall be established on the Forest Land.
- We hereby agree and give undertaking that, if required sufficient firewood preferably alternative fuel shall be provided to labors working for project.
- We hereby agree and give undertaking that the boundary of the Forest Land shall be suitably demarcated on the ground.
- We hereby agree and give undertaking that no additional or new path will be constructed inside the Forest Area for transportation of construction materials.
- We hereby agree and give undertaking that the period of the diversion under this approval shall be co-terminus with the period of lease.
- We hereby agree and give undertaking that the forest land shall not be used for any purpose other than that specified.
- We hereby agree and give undertaking that the Forest Land proposed to be diverted shall under no circumstances be transferred to any other agencies.
- We hereby agree and give undertaking that we shall adhere to all rules, regulation guidelines and acts enforced by the State Government and Central Government.
- We hereby agree and give undertaking that we are aware, violation of any of these conditions will amount to violation of Forest (Conservation) Act-1980.
- We hereby agree and give undertaking that any other conditions that the Ministry of Environment Forest and Climate Change from time to time.
