Diversion of 0.0069 ha of forest land for laying of underground Optical Fiber Cable (OFC) in Vaiyampatti to Konnaiyur route through forest areas of Ammankuruchi RF to a distance of 228.60 m for providing 4G Wireless Broadband in Pudukkottai District in favour of the Jio Digital Fiber Private Limited, Chennai- Reg.

Sir.

Please refer to the State Government's letter No.1273/FR.10/2023-1 dated 03.04.2023, and online proposal No. FP/TN/OFC/118876/2021, seeking prior approval of the Central Government for diversion of forest land in accordance with Section'2' of Forest (Conservation) Act, 1980 for the above mentioned project. The project was accorded in-principle approval (Stage-I) by the Central Government vide letter dated 11.05.2023. The State Government letter No. 1273/FR.10/2023-3 dated 26.12.2023 have reported compliance to the conditions stipulated in the in-principle approval;

After careful consideration of the proposal of the State Government, I am hereby directed to convey the Central Government's final approval (Stage-II) under Section 2(1) of Van(Sanrakshan Evam Samvardhan)Adhiniyam,1980 for diversion of 0.0069 ha of forest land for laying of underground Optical Fiber Cable (OFC) in Vaiyampatti to Konnaiyur route through forest areas of Ammankuruchi RF to a distance of 228.60 m for providing 4G Wireless Broadband in Pudukkottai District in favour of the Jio Digital Fiber Private Limited, Chennai, for a period of 20 years, subject to the following conditions:-

(i) Legal status of the diverted forest land shall remain unchanged.

- (ii) Demarcation of the proposed forest area shall be carried out by erecting 4 feet high cement concrete pillars duly numbered at the appropriate distance as decided by the DFO concerned, at the cost of User Agency;
- (iii) The maximum size of the trench shall not exceed 2.00 m depth, 228.6 m length and 0.30 m width. The forest land shall be restored to its original state after laying the same;
- (iv) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- (v) No labour camp shall be established on the forest land.
- (vi) Disturbance shall be kept minimal by creating labour camps outside the forest area as far as possible and it will be the responsibility of the User Agency to ensure that the machinery, labourers & staff engaged in execution of work shall not destruct nearby forest flora & fauna;
- (vii) Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.

(viii) No tree felling shall be carried out by the User Agency;

- (ix) The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, department or person without prior approval of the Central Government;
- (x) The total forest area utilized for the project shall not exceed **0.0069 ha** and the forest area diverted shall not be used for any purpose other than those shown in the diversion proposal;
- (xi) User Agency and the State Government shall ensure compliance to provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project;
- (xii) Any other conditions that the Central Government or Regional officer(Central) of the Regional Office, Chennai may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the User Agency;

(xiii) Violation of any of the above conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adihiniyam 1980 and action would be taken as per Rules and Guidelines issued there under.
