3.	The State Government shall plant 3500 trees to maintain the green cover at the project cost. Planting site for the propose shall be identified by the State Forest Department preferably within or in the surrounding area of the project. Indigenous tree species should be preferred for such plantation. The user agency shall transfer the cost of plantation and its maintenance for 10 years ( revised as on the date to incorporate the existing wage structure ) to state Forest Department.	Agreed.
4.	User Agency should ensure that the compensatory levies (CA Cost, NPV, etc.) are deposited through challan generated online on web portal and deposited in appropriate bank online only. 8.	The forest land to be diverted, under no circumstances, to be transferred to any other agency, department or person without prior approval of the Ministry of Environment, Forest and Climate Change.	Agreed.
9.	The user agency and the State Government shall ensure compliance of the provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project.	Agreed.
10.	Any other condition that the Ministry of Environment, Forest & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency.	Agreed.
