vi.	The user agency shall seek permission from Forest Department, Dadra & Nagar Haveli for carrying out maintenance.	Agreed by the User Agency
vii.	The User agency shall be responsible for any loss to the flora/fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	Agreed by the User Agency The best possible and strict measures shall be taken to conserve the flora/fauna during construction.
viii.	The User agency shall obtain the Environmental Clearance before the formal order if applicable.	Not applicable as stated by User Agency.
ix.	All statutory provisions under various acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed by the User Agency.
x.	All the fund received from the user agency under the project shall be transferred to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank A/c No. SB01025204 (CAF D&NH) in Corporation Bank , Lodhi Complex , New Delhi - 110003. xi.	The User agency has to pay ₹ 6,42,276/- towards Net Present value of land and ₹ 8,00,592/- towards Compensatory Afforestation including maintenance for 10 years.	The payment has been transferred towards the details mentioned in the challan generated from the website.
