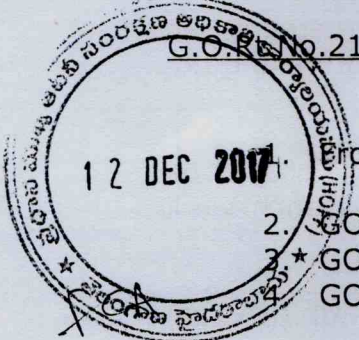

ORDER:

In his letter 1st read above, the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad has submitted a proposal for diversion of **0.8128 ha** of forest land in Mulugu and Tadvai forest divisions in Jayashankar District, Bhupalpally for laying of Optical Fiber Cable along the road and within the existing Right of Way in favour of M/s.Idea Cellular Limited.

2. Government, after careful examination of the proposal of the Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad and in the light of the guidelines issued by the Government of India, Ministry of Environment & Forests, in the letters 2nd to 4th read above, hereby accord permission to the Principal Chief Conservator of Forests (HoFF), Telagana State, Hyderabad, for diversion of **(0.5339 & 0.2789 ha)** of forest land in Mulugu and Tadvai divisions **totaling 0.8128 ha** in Jayashankar District, Bhupalpally for laying of Optical Fiber Cable along the road and within the existing Right of Way in favour of M/s.Idea Cellular Limited, subject to fulfillment of the following parameters / conditions:-

- i. The proposed work should be carried out without felling of trees.
- ii. The maximum size of the trench is 2.00 mtrs depth and 1.00 mtr width.
- iii. Laid out along the road and within the existing right of way
- iv. The User Agency to make good the land after use/ maintenance.
- v. The User Agency to make good any loss to forests / environment.
- vi. The User Agency should take permission for carrying out any maintenance.
- vii. The User Agency should pay compensation for the felled & damaged trees, if any.
- viii. They should not disturb / damage flora and fauna during the execution of the project. They should try to avoid tree damage during execution of work.

- ix. The user agency should follow F(C) Act-1980 strictly.
 - x. Erection of publicity sign boards (4) no's with the size of (8"x12") should be taken up across the division at designated place demarcated by FD.
 - xi. (2) nos solar powered bore wells with percolation tank should be developed by user agency for the protection of flora and fauna in the division.
 - xii. RCC Boundary pillars of 4 feet height have to be constructed at an interval of 20 Mtrs apart between the boundary road and RF along the OFC line.
 - xiii. Trench work for laying of optical fiber in Tadvai (T) Range should be carried out carefully to avoid any tree damage. For this trench work should be taken up manually to avoid tree damage.
 - xiv. Erection of publicity sign boards (6) no's with the size of (8"x12") should be taken up across the division at designated places demarcated by Forest Department.
 - xv. (2) nos solar powered bore wells with percolation tank should be developed by User Agency for wildlife in the division.
 - xvi. RCC Boundary pillars of 4 feet height have to be constructed at an interval of 20 Mtrs apart between the boundary road and RF along the OFC line.
3. The Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad shall take necessary action, accordingly.


