In this scheme, there is provision for laying of 1118mm dia 8.7mm thich MS pure water gravity main in the forest reach for a length of 2.4735 Kms. For this purpose 0.9894 ha of forest land in Sy. No.126, 129, 142, 143, 145 & 2 of Kattaya Village, Hassan Taluk & District has to be diverted for providing water supply to Hassan city in favour of the Executive Engineer, Karnataka Urban Water Supply and Drainage Board (KUWS&DB), Division, M.G.Road, Hassan.
