Sir,

With reference to the subject cited above, I am to inform you that, the minimum wage rate has increased from **525 to 541** per day, hence Compensatory Afforestation has also increased from **Rs 1,11,21,975/- to 1,13,17,851/-**. In this regard, I am putting again the updated demand note in component wise as mention below:

1. As per point no. A (1) & (2) of the Stage I approval, you shall pay the cost of raising Compensatory Afforestation amount to **Rs 1,13,17,851/- (Rupees One Crore Thirteen Lakhs Seventeen Thousand Eight Hundred Fifty One only)** and Net Present value (NPV) of **Rs 74,07,471/- (Rupees Seventy Four Lakhs Seven Thousand Four Hundred Seventy One only)** respectively by transferring / depositing into the CAMPA fund through e-portal (<https://parivesh.nic.in/>).
2. As per point no A (5) of the Stage I approval, you shall pay the cost towards Mitigation measures for conservation of Dark Swift & Red Serow and for awareness creation of **Rs 12,50,000/- (Rupees Twelve Lakh Fifty Thousand only)** shall be transferred / depositing into the current A/c of The Divisional Forest Officer, Khasi Hills Wildlife Division, East Khasi Hills Shillong, A/c No. **30050705699, IFSC Code SBIN0002081**.
3. As per point no A (6) and point no (8) of the Stage I approval, you shall transfer the cost of demarcation pillars of 8 numbers amounting to **Rs 49,600/- (Rupees Forty Nine Thousand Six Hundred only)** and cost of felling amounting to **Rs 15,60,500/- (Rupees Fifteen Lakhs Sixty Thousand Five Hundred only)** respectively shall be transferred / depositing into the current A/c of The Divisional Forest Officer, East Khasi Hills & Ri-Bhoi (T) Division, Shillong, A/c No. **30852745780, IFSC Code SBIN0002081**.
