I enclose herewith a copy of the letter cited along with statutory proforma proposal under Forest (Conservation) Act, 1980, submitted by the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh for diversion of 3.37 ha in compartment Nos.379 & 380 of Mathumuru beat, Saluru Section / Range, Vizianagaram for formation of road from Vetaganivalasa to Thangalam in favour of Executive Engineer, Panchayat Raj (PIU) Division, Vizianagaram.

2. I am to inform that the User Agency i.e. Executive Engineer, PR (PIU) Division, Vizianagaram, has furnished justification stating that the villagers of Thaglam, Jeerikavalasa and Chittelaba can reach the Mandal head quarters Pachipenta with shortest path by providing this road. The road passes through RF at various reaches in the road from 11/000 to 15/834 km. This is the only the shortest route for the people of above habitations. The buses and commercial vehicles are not plying on this road due to improper geometry and various streams crossing the road. The people are facing lot of problems to meet their needs of education, health and transportation of agricultural and forest produces etc. The User Agency has identified non-forest land over an extent of 3.37 ha in survey No.108 of Pedakhandepalli Village, S.Kota Mandal, Vizianagaram District for CA purpose. The User Agency has furnished undertakings for payment of NPV, Addl. NPV, CA and tree extraction charges etc. The District Forest Officer, Vizianagaram has prepared CA scheme with a financial out lay of Rs. 25.66 lakh for a period from 2022-23 to 2033-34 with 10 years of maintenance. The District Collector, Vizianagaram District has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The proposal has been uploaded in the Ministry's website and unique file No.FP/AP/ROAD/141402/2021 has been generated for this proposal. The concerned District Forest Officer, the Chief Conservator of Forests and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively. The recommendation of the State Government in proforma proposal in Part-V is enclosed herewith.

I request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under Section-2 of Forest (Conservation) Act, 1980, for diversion of 3.37 ha in compartment Nos.379 & 380 of Mathumuru beat, Saluru Section / Range, Vizianagaram for formation of road from Vetaganivalasa to Thangalam in favour of Executive Engineer, Panchayat Raj (PIU) Division, Vizianagaram, at the earliest.


