No. 333 of Rapur-Veligonda Block "A" Extn "B" RF and Compt. No. 331 of Rapur-Veligonda Extn "C" RFs of Rapur Range for laying of underground Optical Fiber cable by M/s Vindhya Telelinks Ltd., Secunderabad" subject to certain stipulated conditions.
