Adverting to the subject and references cited above, it is informed that, the Government of India, Ministry of Environment, Forests & Climate Change, New Delhi vide reference 1st cited have accorded in-principle (Stage-I) approval for 1st Renewal for diversion of 124.00 (Surveyed 124.065 Ha) of Forest land for GKOC Phase-II, Kothagudem in Ramavaram Range of Kothagudem Division, Bhadradri Kothagudem District in favour of M/s Singareni Collieries Company Limited, Kothagudem.

The Principal Chief Conservator of Forests (HoFF), Telangana State, Hyderabad vide reference 2nd cited issued instructions to prepare demand note to the User Agency for payment of compensatory levies by the User Agency (condition No. iii & ix) and also ensure that the compliance conditions stipulated are complied which is mandatory for getting the Stage-II clearance for this Project and furnish the same through CCF, Warangal.

Further it is submitted that, the SCCL Kothagudem area has identified the Non forest land to an extent of 495.088 Ha in Sy.No. 116 of Rasannagudem Village of Mulakalapally Mandal of Paloncha Forest Division to handed over to the Forest Department on 06.03.1990 in lieu of forest area diverted for various projects of SCCL in two (2) Bits i.e., 261.31 Ha(Bit-I) and 233.77 Ha (Bit-II). List of Projects wise CA land handed over by the SCCL is as follows.

It is submitted that, out of 495.08 Ha, an extent of 261.31 Ha was notified U/s. 4 of Indian Forest Act, 1927. At the time of handover CA land the year 1990 survey conduct the area arrived as 233.77 Ha notification proposals are not finalized due to encroachments. After conducting the DGPS survey in the year 2019, actual area was arrived as 210.00 Ha instead of 233.77 ha and thus shortfall of 23.77 Ha. The SCCL has given Short fall area 23.77 Ha of Non Forest land identified in JKOC-II rehabilitated dump areas and the SCCL has also agreed to pay the cost towards raising CA in equal extent (24 Ha) in degraded forest land in Gangaram Range, Gudur Division, Mahabubabad District.

Further, it is submitted that, the CA land identified to an extent of 124.00 Ha (part of the 210.00 ha), during the joint inspection it was noticed that, to an extent of 81.04 ha under encroachment, only area 42.96 Ha available (free from encroachment) and submit the notification proposals, accordingly the Government of Telangana notified U/s 4 TSF Act, 1967 to an extent of 42.965 ha (Ac.106.07 gts) as Rasannagudem-III CA block vide G.O.Ms No. 53, EFS&T(For.I) Dept, dt:30.05.2025. Further, it was also noticed that an area of 61.66 Ha of CA taken from SRLIP (during 2018) is overlapping on the area already handed over by the SCCL as above CA land during 1990. The SCCL authorities has identified the Non Forest land to an extent of 205.60 Ha from Rajupeta Land bank of Mangapeta Mandal allotted to an extent of 142.70 Ha for GKOCP-II (81.04 ha under encroachment and area of 61.66 Ha of CA taken from SRLIP (during 2018) is overlapping, total 142.70 Ha) and to an extent of 58.5105 Ha of Manuguru OCP extension project.

Further as per Stage-I condition No. iii, the District Forest Officer, Mulugu has submitted the CA NFL scheme to an extent of 142.70 ha for GKOCP-II project to amount of Rs. 1126.29490 lakhs, in turn, vide reference 3rd cited, CA-NFL scheme approved by the Chief Conservator of Forests, Kaleshwaram to amount of Rs. 1126.29490 lakhs which was prepared by the District Forest Officer, Mulugu.

Hence, the User Agency i.e., the General Manager, SCCL, Kothagudem area is requested to make necessary arrangement as per condition No.ix for payment of Compensatory levies amount through generate e.challan in parivesh protal, into the account of National Authority, CAMPA and submit the condition wise compliance of Gol Stage-I conditions to this office immediately for obtaining Stage-II approval from the MoEF, Gol.
