In order to ensure compliance of conditions at Sr. No. 5 & 8 stipulated by MoEF&CC, GoI, vide above referred stage-I approval letter for proposal for diversion of 54.8724 Ha. Forest Land for Development of Urban Extension Road-II, you are hereby requested to deposit the const of compensatory afforestation to be maintained for 10 years and Net Present Value (NPV).

Since, this proposal is falling in two Forest Divisions, the following amount CA and NPV are against the diversion of 37.7726 Ha. land to be diverted in the jurisdiction of North Forest Division only:


1. The cost of Net Present Value i.e. NPV is calculated @ Rs. 8,87,000/- (Rs. Eight Lakh Eighty Seven Thousand only) per Hectare for 37.7726 Ha. i.e. **3,35,04,296/- (Rs. Three Crore Thirty Five Lakh Four Thousand Two Hundred Ninety Six only).**
2. Total cost of Compensatory Afforestation for area to be diverted under North Forest Division i.e. 37.7726 is **Rs. 45,55,59,462/- (Forty Five Crore Fifty Five Lakh Fifty Nine Thousand Four Hundred Sixty Two only)**
3. Total amount of CA and NPV to be deposited is **Rs. 48,90,63,758/- (Rs. Forty Eight Crore Ninety Lakh Sixty Three Thousand Seven Hundred Fifty Eight only)**
4. The payment shall be deposited to CAMPA fund only through e-portal (<http://parivesh.nic.in>) and receipt shall be deposited in this office.

In the above subject NHAI has applied for the diversion of 17.0998 Ha. forest land for the construction of Urban Extension Road -II vide online Parivesh ID: FP/DL/Road/49252/2020 . As per the conditions stipulated in the stage-I approval letter issued by Regional Office you are advised to deposit the following requisite amount.

1. Cost of compensatory afforestation over 17.0998 Ha. Non-Forest Land (Land allocated at Holambi Kalan, Sanath, Narela , Dichaon Kalan, Nizamudin , New Delhi). Total Payable amount is Rs. 15,06,87,750 (Fifteen Crore Six Lakh Eighty Seven Thousand Seven Hundred Fifty Only).
 2. Cost of Net present Value @ 8,87,000 Per ha. for the Diversion of 17.0998 Ha. forest land, Total Payment amount is 1,51,67,523 (One Crore Fifty One Lakh Sixty Seven Thousand Five Hundred Twenty Three Only).
 3. Land to be handed over to the Department at earliest with demarcation pillars.

You are requested to submit a point wise compliance report of the conditions stipulated by the Ministry of Environment ,Forest & Climate Change , Integrated Regional Office, Jaipur. (Copy Enclosed).

In addition to the above you are also requested to submit details of transplantation site for transplantation of indigenous species and transplantation timeline/schedule in compliance of point no. 16 separately.
