ORDER

In pursuance of the guidelines issued by the Ministry of Environment & Forests, Government of India, referred above In-Principle approval was accorded for Diversion of 0.989 Ha. Protected Forest Land for the integrated Water Management Plan W.D. - III for Umarvarni, Khutli, Khanvel, Talavali and Shelti village in the U.T. of Dadra & Nagar Haveli, Silvassa vide letter mentioned at preamble (ix) above and on receipt of payment of ₹21,63,498/- (Rupees: Twenty One Lakh Sixty Three Thousand Four Hundred Ninety Eight only) through RTGS/NEFT (Challan) mode in Corporation Bank, New Delhi by the User Agency the Executive Engineer, PWD, Civil Division No. III (Irri.), Dadra & Nagar Haveli, Silvassa towards cost of Net Present Value and Compensatory Afforestation for the diversion of 0.989 hect. of Protected Forests land approved for diversion as per order of Hon'ble Supreme Court (IA-566 in W.P. (Civil) No. 202/1995) dated 30.10.2002, 01.08.2003, 28.03.2003 and 09.05.2008, the undersigned on behalf of the Administration of Dadra & Nagar Haveli is hereby pleased to permit the User Agency the Executive Engineer, PWD, Civil Division No. III (Irri.), Dadra & Nagar Haveli, Silvassa to use 0.989 hect. of Protected Forest land for the integrated Water Management Plan W.D.- III for Umarvarni, Khutli, Khanvel, Talavali and Shelti village in the U.T. of Dadra & Nagar Haveli, Silvassa as indicated in the application and the map enclosed alongwith application, subject to the following conditions :-

- i The legal status of the forest land shall remain unchanged i.e. shall remain Reserved / Protected / Village / other types of forests as the case may be.
- ii No felling of tree shall be involved in the implementation of the proposal.
- iii The maximum size of the trench shall not be more than 2.00 meter depth and 1.00 meter width.
- iv The pipeline shall be along the road within existing right of way not falling in National parks and Wildlife sanctuaries.
- v Compensatory afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 Years. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the State Forest department.
- vi The User agency shall seek permission from local Forest Department for carrying out any maintenance;
- vii All statutory provisions under various Acts, Rules there under and guidelines applicable to this project shall be strictly adhered to.
- viii The forest land shall not be used for any purpose other than that specified in the proposal.
- ix The User agency shall be responsible for any loss to the flora / fauna in the surroundings and therefore, shall take all possible measures to conserve the same.
