vi.	The user agency shall seek permission from Forest Department, Dadra & Nagar Haveli for carrying out maintenance.	Agreed by the User Agency
vii.	The User agency shall be responsible for any loss to the flora/fauna in the surroundings and therefore, shall take all possible measures to conserve the same.	Agreed by the User Agency The best possible and strict measures shall be taken to conserve the flora/fauna during construction.
viii.	All the statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed by the User Agency
ix.	It will be the responsibility of the User Agency to ensure that the labourers and staff engaged in construction activity do not damage forest flora and fauna.	Agreed by the User Agency
x.	The forest land proposed to be diverted shall under no circumstance be transferred to any other agencies, department or person without prior approval of Central Government	Agreed by the User Agency
	All the funds received from the user agency under the project shall be transferred / deposited to CAMPA fund only through e.portal (http://forestclearance.nic.in).	The payment has been transferred towards the details mentioned in the challan generated from the website.

xiii.	The User agency has to pay ₹ 9,28,671/- towards Net Present value of land and ₹ 12,34,827/- towards Compensatory Afforestation including maintenance for 10 years.
