May kindly peruse the letter No. PWDIII/IRRI/DP/FC/2018/239 dated 31.01.2018 received from Executive Engineer, PWD Civil Division No. III (Irri.), Dadra & Nagar Haveli, Silvassa regarding compliance of In-Principle Approval of Diversion of 0.4125 Ha. of Reserved Forest Land for providing drinking water supply scheme (Pipeline) in Gunsa and Bildhari in the U.T. of Dadra & Nagar Haveli.

The point wise compliance is as under:

4	Compensatory afforestation shall be taken up by the Forest Department at the cost of the user agency and the same shall be maintained for 10 Years.. Only indigenous forest tree species shall be used for such plantations. Trees, if planted on the diverted area, will not be felled without the permission of the State Forest department	Agreed by U.A.
5	The User agency shall pay the Net Present Value (NPV) of the diverted forest land at the rates stipulated by the Ministry of Environment and Forests from time to time.	Agreed by U.A.
6	Additional amount of the NPV of the diverted forest land if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.	The undertaking has been submitted by the U.A. For depositing the Additional NPV after finalization of same by the Hon'ble Supreme Court may please be seen at page C/85.
7	The User agency shall seek permission from local Forest Department for carrying out any maintenance;	Agreed by U.A.
8	All statutory provisions under various Acts, Rule there under and guidelines applicable to this project shall be strictly adhered to.	Agreed by U.A.
9	The User agency Shall Transfer the fund to be paid by them to the Ad-hoc Compensatory Afforestation Fund Management & Planning Agency (CAMPA) in Saving Bank Account No. SB01025204 (CAF D&NH) in Corporation Bank, Lodhi Complex, New Delhi - 110 003..	The payment has been transferred towards the details mentioned in the challan generated from the website vide UTR No. BKDNH17362702645 may please be seen at page C/131.

10	The User Agency has to pay Rs. 3,87,338/- towards Net Present Value of the Land and Rs. 4,82,812/- towards Compensatory Afforestation including maintenance for 10 years	The payment has been transferred towards the details mentioned in the challan generated.
11	The forest land shall not be used for any purpose other than that specified in the proposal	Agreed by the User Agency.
