**विषय: Final (Stage-II) approval of Central Government under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for diversion of 0.62935 ha of forest land in favour of Gas Authority of India Ltd for installation of Barauni-Guwahati 24"dia natural gas pipelines in Begusarai, Khagaria, Madhepura, Purnia and Kishanganj districts of Bihar- reg.**

Sir,

I am directed to refer to the State Govt.'s letter No.Van Bhumi-07/2020-261(E)/Pa.Va.Ja.Pa. dated 20.02.2020 on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest and Climate Change under section 2 of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980. After due consideration of the proposal of State Government, the '**in-principle**' approval for diversion of 0.62935 ha. of forest land was accorded by this office vide letter of even number dated 07.04.2020 subject to fulfillment of certain conditions. The State Government has furnished compliance report in respect of the conditions stipulated in the in-principle approval and has requested to grant final approval.

In this connection, I am directed to say that on the basis of the compliance report furnished by the State Government of Jharkhand vide letter No. Van Bhumi-07/2020-144(E)/Pa.Va.Ja.Pa. dated 12.03.2024, **final approval** of the Ministry of Environment, Forests & Climate Change is hereby granted under Section 2 of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for diversion of 0.62935 ha of forest land in favour of Gas Authority of India Ltd for installation of Barauni-Guwahati 24"dia natural gas pipelines in Begusarai, Khagaria, Madhepura, Purnia and Kishanganj districts of Bihar, subject to the following conditions and stipulations:

- (1) Legal status of the forest land shall remain unchanged.
- (2) Compensatory afforestation shall be taken up by the State Forest Department for plantation of 1270 trees to maintain the green cover at the project cost. Planting site for the purpose shall be identified by the State Forest

Department preferably within or in the vicinity of the project sites. Indigenous tree species should be preferred for such plantation.

- (3) All the funds received from the user agency under the project shall be transferred / deposited to CAMPA fund only through e-portal (<https://parivesh.nic.in/>).
- (4) No trees will be felled under this diversion, and the 346 trees as per enumeration list required to be removed from the pipeline strip of forest lands will be transplanted under the supervision of State Forest Department at the project cost.
- (5) The KML files of the area to be diverted and the CA area shall be uploaded on the e-Green watch portal before issuing of final approval by the State Government of Bihar.
- (6) The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
- (7) Wherever possible and technically feasible, the User Agency shall undertake appropriate afforestation measures around the sites related to the area diverted under this approval, in consultation with the State Forest Department at the project cost.
- (8) The pipeline shall be laid down 1.5 meter below the ground and after laying down of pipe line the ground will be leveled.
- (9) The User Agency shall obtain Environmental Clearance as per the provisions of the Environmental (Protection) Act, 1986, if applicable.
- (10) The layout plan of the proposal shall not be changed without prior approval of the Ministry of Environment, Forest & Climate Change.
- (11) No labour camp shall be established on the forest land.
- (12) Sufficient firewood, preferably the alternate fuel, shall be provided by the User Agency to the labourer after purchasing the same from the State Forest Department or the Forest Development Corporation or any other legal source of alternate fuel.
- (13) The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
- (14) No additional or new path will be constructed inside the forest area for transportation of construction materials for execution of the project work.
- (15) The period of diversion under this approval shall be co-terminus with the period of lease to be granted in favour of the user agency or the project life, whichever is less.

- (16) The forest land shall not be used for any purpose other than that specified in the project proposal.
- (17) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Govt. of India.
- (18) The User Agency and the State Government shall ensure compliance to provisions of all the Acts, Rules, Regulations, Guidelines, Hon'ble Court Order(s) and National Green Tribunal Order(s) pertaining to this project, if any, for the time in force, as applicable to the project.
- (19) Violation of any of these conditions will amount to violation of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and action would be taken as per the MoEF&CC Guideline F. No. 11-42/2017-FC dt 29/01/2018.
- (20) Any other condition that the Ministry of Environment, Forests & Climate Change may stipulate from time to time in the interest of conservation, protection and development of forests & wildlife.

As has been mentioned at Para-2 of the Stage-II approval, this approval for diversion of forest land is subject to the fulfillment of stipulated conditions mentioned in this approval letter. Therefore, in the event of non-compliance of any of the conditions laid out in this approval letter, the Regional Office of Ministry of Environment, Forest & Climate Change may withdraw the said approval for diversion of the forest land and stop the non-forest activity being carried out in the forest land besides initiating the legal action as per provisions of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.
