I submit that the Government of India and Government of Andhra Pradesh in the references 1st & 2nd cited, have accorded in-principle (Stage-I) approval for Diversion of 0.39 Ha of Forest land in Tarimela RF, Ananthapuramu Division for Construction of Percolation Tank in favour of Technical Director, Rural Development Trust, Ananthapuramu subject to the fulfillment of specified conditions and the same was communicated by the Prl. Chief Conservator of Forests, Andhra Pradesh, Guntur in the reference 3rd cited.

The Forest Range Officer, Ananthapuramu in the reference 5th cited has submitted the compliance report on the conditions stipulated in the Stage-I approval accorded by the GOI.

The User agency in the reference 4th cited has submitted the payment receipt for the amounts deposited towards Net Present Value (NPV), Compensatory Afforestation (CA), for taking further action in the matter.

The compliance report on fulfillment of the conditions stipulated in the reference 1st cited is furnished hereunder as submitted by Forest Range Officer, Ananthapuramu.

The forest clearance copies were circulated to the Tahsildar, Singanamala mandal, Executive Officer, Tarimela Panchayat of Singanamala mandal of Ananthapuramu District to display the same on the notice board.



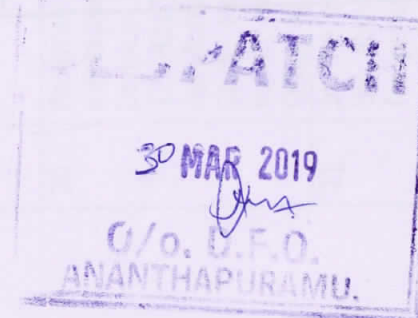
