It is to inform that, the Principal Chief Conservator of Forests (HoFF), Telangana Hyderabad vide reference 4th cited while communicating the **Stage-I (in-principle) approval accorded** in reference 3rd cited for diversion of forest land to an extent of **1.8584 ha** of Forest land in Kaghaznagar Division of KB Asifabad District has issued instructions to raise the demand note as per the actual rates and issue demand note to the User Agency only after vetting of the demand note by the Nodal Officer. Further it is reported that, the Principal Chief Conservator of Forests, Chief Wildlife Warden, Telangana, Hyderabad vide reference 6th cited has communicated the NBWL approval of the subject project and requested to raise demand notice to user agency accordingly.

Further it is informed that, the demand notice is vetted by O/o the CCF/FDPT, KTR. Mancherla vide reference 8th cited and instructed to issue the demand notice to the User Agency.

In view of the above, the User Agency is requested to deposit the following amount for an extent of **1.8584 Ha of Kaghaznagar Division** as follows and requested to go through the references carefully and fulfillment all the conditions stipulated in the reference 3rd to 6th cited above and report compliance. Further, the User Agency is requested comply the following:

1. In accordance with the MoEF & CC, GoI instructions issued vide F.No.7-23-2012-FC, dt.24.07.2013 communicated vide PCCF., Hyderabad Rc.No.45921/2001/F4, Dt: 23.08.2013 the following shall be complied:
 1. Publish the entire forest clearances granted to the project proponent for the use of forest land for the non-forest purpose in verbatim along with the conditions and safe-guards imposed by the Central Government in two widely circulated daily newspaper i.e., one in vernacular language and the other in English.
 2. The copies of the clearance should also be submitted to the heads of local bodies, Panchayats and Municipal bodies by the project proponents in addition to the relevant offices of the Government who in turn has to display the same for 30 days from the date of receipt of this reference.
2. Further the User Agency is requested to submit separate undertakings for each of the condition Nos. 1, 4, 6.b., 7, 8 to 21 as in the approval letter by IRO and also Govt. of Telangana communicated by the Principal Chief Conservator of Forests, (HoFF), Telangana, Hyderabad. Further the UA shall comply to the instructions of the Principal Chief Conservator of Forests, (HoFF), Telangana, Hyderabad communicated vide ref, 3rd and 4th cited above.
3. Further the User Agency is requested to submit separate undertakings for each of the condition Nos. (1) to (13) as per the MoM of 72nd SC-NBWL meeting held on 12.06.2023 and communicated by the Prl. C.C.F., CWW, TS, Hyderabad Rc. No. 15252/2021/WL-1, Dt.01.08.2023.
4. Further, the User Agency shall be requested to submit the details of payments made and submit seven sets of compliance report on all the conditions stipulated in Stage-I approval and in NBWL approval along with all the necessary documents, certificates, undertaking and also paper clippings etc., for onwards submission to the competent authority for issue Stage-II approval.
