Sub: In-principle (Stage-I) approval of Central Government under Section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 for non-forestry use of 0.03128 ha of forest land in favour of PHE Department, Govt. of Sikkim for augmentation of water supply system (laying of water pipeline and construction of water tank having 60000 ltrs capacity) from Bulbuley to Dechiling in Gangtok district of Sikkim - reg.

Sir,

I am directed to refer to letter No.2085/FCA/F&ED/2023 dated 6.12.2023 of the Government of Sikkim on the above-mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under section 2 (1) (ii) of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980.

After due consideration of the proposal of the State Government, the Ministry of Environment, Forest & Climate Change hereby conveys '**Stage-I/in-principle**' approval for non-forestry use of 0.03128 ha of forest land in favour of PHE Department, Govt. of Sikkim for augmentation of water supply system (laying of water pipeline and construction of water tank having 60000 ltrs capacity) from Bulbuley to Dechiling in Gangtok district of Sikkim subject to the following conditions and stipulations:

1. Legal status of forest land proposed for diversion shall remain unchanged.
2. The user agency shall transfer the cost of raising and maintenance of the compensatory afforestation (100 trees plantation and maintenance for 10 years) at the current wage rate in consultation with State Forest Department in the account of CAMPA of the concerned State through online portal.
3. The State Forest Department shall raise these 100 plants towards compensatory afforestation within three years from the issue of approval preferably in the vicinity of the project site and maintained thereafter. The State Government will inform the site of plantation to the Regional Office. Eighteen months old indigenous tree species should be planted.


4. The State Government shall charge the Net Present Value (NPV) for the 0.03128 ha forest area to be diverted under this proposal from the User Agency in accordance with the MoEF&CC's guidelines dated 6.01.2022 read with guidelines dated 19.01.2022.
5. At the time of payment of Net Present Value (NPV) at the present rate, the User Agency shall furnish an undertaking to pay the additional amount of NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India.
6. All the funds received from the user agency under the project shall be transferred / deposited to CAMPA fund only through **e-portal** (<https://parivesh.nic.in>).
7. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector.
8. The boundary of the diverted forest land shall be suitably demarcated on ground at the project cost, as per the directions of the concerned Divisional Forest Officer.
9. Wherever possible and technically feasible, the User Agency shall undertake appropriate afforestation or vegetation enrichment measures near the site(s) related to the area diverted under this approval, in consultation with the State Forest Department at the project cost.
10. The lay out plan of the proposal shall not be changed without prior approval of the Central Government.
11. (a) All the natural streams and water bodies in surrounding area shall be protected.
(b) The User Agency shall ensure that the labourers and staff engaged in construction activity do not damage the nearby forest flora and fauna.
(c) Earth or any other material shall not be brought from and debris resulting during construction shall not be disposed of in the adjoining forest area by the user agency.
(d) No labour camp shall be established on the forest land.
(e) The User Agency shall provide alternate fuels preferably LPG to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas.
(f) During and after the construction period of the project, the project authority shall continue to assist the State Forest Department for conservation and development of natural resources of the State.
12. (a) The forest land shall not be used for any purpose other than that specified in the Project proposal.
(b) The period of diversion under this approval shall be co-terminus with the period of the project life.

(c) The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without prior approval of Central Government.

13. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of Comprehensive Guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No.5-2/2017-FC dated 28.03.2019.
14. Any other conditions that the Ministry of Environment, Forest & Climate change may stipulate from time to time in the interest of conservation, protection and development of forest and wildlife.
15. The compliance report shall be uploaded on *e-portal* (<https://parivesh.nic.in>).

After receipt of the compliance report from the State Government regarding due compliance and fulfillment of the above conditions as stipulations, formal approval will be issued in this regard under Section 2 of Forest (Conservation) Act, 1980. **Transfer of forest land by the State Government to the user agency should not be given effect to till formal order approving diversion of forest land is issued by the Central Government.**


