- 2. I wish to inform that the user agency in their justification report stated that the area to be diverted is situated in a backward drought prone District of Ananthapuram of Andhra Pradesh State. Now a days, a number of Industries are establishing, so requirement of Barytes is more. The area is surrounded by Ellutla Reserve Forest and as per the report of Assistant Director of Mines & Geology, it is a rare material and not available in the nonforest lands in Ananthapuram District and there are no existing lease for Barytes in the nonforest land. The user agency has submitted certificate /undertakings regarding safety zone plantation, payment of Net Present Value (N.P.V.) and additional N.P.V., and other undertakings as per norms. The District Collector, Ananthapuram has issued necessary certificates under Scheduled Tribes & Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006. The concerned field officers and the Principal Chief Conservator of Forests & Head of Forest Force, have recommended the proforma proposal in Part-II, III and IV respectively. The proforma proposal in Part-V is herewith enclosed.
- 3. I, request you to obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under section 2 of Forest (Conservation) Act, 1980, for diversion of 1.95 Ha., of forest land in Sy.No.01/P (Compt.No.558) of Ellutla RF, Putlur Mandal, Ananthapuram District for mining lease for extraction of Barytes, in favour of Smt.J.C.Vijaya, R/o.Tadipatri, at an early date.
