In continuation of this office reference 4th cited and in compliance to the reference 3rd cited, it is to informed that, in the reference 2nd cited, the Prl. Chief Conservator of Forests (HoFF) A.P., Mangalagiri has communicated the Stage-I approval accorded by the GoI MoEF & CC, IRO, Vijayawada for Diversion of 2.18 ha forest land (1.25 ha within the existing RoW in 6 stretches & 0.93 ha not covered in RoW in 3 stretches for laying underground Optical Fiber Cable along the road passing through forests of Chintapalli (erstwhile Narsipatnam) Division for providing 4G communication in the State of Andhra Pradesh in favour of M/s Reliance Jio Infocomm Ltd, Visakhapatnam.

As per the Stage-I approval under condition no.3 the User Agency has to be paid the cost of Raising of Plantation in 4.36 ha in degraded forest area. In this regard the C.A. Scheme approved by the Chief Conservator of Forests,

Visakhapatnam for 28.371 Lakhs vide reference 3rd cited. Hence, the User Agency pay the C.A. amount through e-portal <https://parivesh.nic.in/> as detailed below.


