Sub: Forests – Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 - Proposal No.FP/TN/Others/42934/2019 - Proposal for diversion of 0.1212 ha of forest land in Thiruthuraiyur Reserved Forest of Cuddalore Forest Division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District – In principle approval – Requested - Regarding.

I am directed to enclose a copy of the reference first and third cited and to state that, the Principal Chief Conservator of Forests (Head of Forest Force) in his letter first cited has stated that, the User Agency, the Block Development Officer, Panchayat Union Office, Annagramam, Cuddalore District has uploaded online forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.1212 ha of forest land in Thiruthuraiyur Reserved Forest of Cuddalore Forest Division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District under the Proposal No.FP/TN/Others/42934/2019.

- 2. In the Part-II of Form-A, the District Forest Officer, Cuddalore Division has furnished the following particulars:
  - i) Forest area diversion of 0.1212 ha of forest land in Thiruthuraiyur Reserved Forest of Cuddalore Division has been proposed by the user agency. Eco-class of forest area reported as Eco-Class 5 with density of forest area reported as 0.1.
  - ii) On Brief vulnerability of forest area to erosion reported as 'Not vulnerable to erosion'.
  - iii) Significance of the forest land proposed for diversion reported from Wildlife point of view reported by the District Forest Officer is as follows:
    - a. The District Forest Officer has reported that spotted deer, Wild Pig, Reptiles species are present in and around the forest land proposed for diversion.
    - b. The forest area proposed for diversion is not part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant corridor, Wildlife migration corridor etc., and not located within the Eco-sensitive zone of the protected area notified under wildlife (Protection) Act, 1972 and not located within 1 km from the boundary of the above.
    - c. There is no rare/ endangered / unique species of flora and fauna found in the area.
  - iv) There is no protected archaeological/ heritage site/ defense establishment or any other important monument is located in the area.
  - v) Requirement of forest land as proposed by the User Agency is unavoidable and bare minimum for the project and no work in violation of the Act (or) guidelines has been carried out.
  - vi) For the diversion of 0.1212 ha of forest land, compensatory afforestation has been proposed for planting of 100 number of seedlings in Thiruthuraiyur Reserved Forest including ten years maintenance period at project cost of Rs.1,73,231/-.
  - vii) The District Forest Officer has uploaded the site inspection report of the proposed forest diversion area.
    - a. The proposal is for diversion of 0.1212 ha of forest land in Thiruthuraiyur Reserved Forest of Cuddalore Forest Division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District and the proposed site has been inspected on 07.01.2021.
    - b. The proposed Thiruthuraiyur Reserved Forest area is having degraded forest, the existing pathway has been utilized by village people to reach the burial ground. The Rural Development Officials (user agency) explained that the activities proposed for electricity connection and bore well are also necessary for burial ground. Right of way is also admitted as per Thiruthuraiyur Reserved Forest notification. No tree felling is required for the project.
    - c. The District Forest Officer has reported that approach road to burial ground is a basic requirement and right of way is also there. The Conservator of Forests, Villupuram Circle has also recommended the project and stated that, approach road to burial ground is a basic requirement and right of way is also there.

d. The diversion of forest area has been requested for following purpose:-

- e. Taking into consideration of the facts stated above, the Conservator of Forest, Villupuram circle and the District Forest Officer, Cuddalore Forest Division in the Part II of Form A has recommended the proposal for diversion of 0.1212 ha of forest land in Thiruthuraiyur Reserved Forest of Cuddalore forest division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District.
- 3. The Principal Chief Conservator of Forests (HoFF) has also stated that, the proposal is sent through Parivesh portal duly recommended by the Principal Chief Conservator of Forests (Forest Conservation Act) / Nodal Officer of Forest (Conservation) Act, of the State of Tamil Nadu in Part-III of Form-A.
- 4. Based on the recommendations made by the District Forest Officer, Cuddalore Division and the Principal Chief Conservator of Forests (Forest (Conservation) Act) of Tamil Nadu, the Principal Chief Conservator of Forests (HoD) has forwarded the proposal for diversion of 0.1212 ha of forest land in Thiruthuraiyur Reserved Forest of Cuddalore Forest Division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District for a period of 30 years, and requested the Government to consider the same and to obtain approval for the same from the Government of India, subject to the following conditions:
  - i) The legal status of the diverted forest land shall remain unchanged.
  - ii) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at the cost of user agency.
  - iii) The user agency has to pay the Net Present Value of proposed forest diversion area which will be fixed as per the guidelines of Hon'ble Supreme Court of India/ Government of India,
  - iv) The user agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by the Forest Department in future. The user agency has to furnish undertaking to this effect.
  - v) Amount of Compensatory Afforestation scheme, Net Present Value of forest area under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/)

- vi) The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.
- vii) The total forest area utilized for the project shall not exceed 0.1212 ha area in Thiruthuraiyur Reserved Forest and the forest area diverted shall not be used for any other purpose other than those shown in the diversion proposal.
- viii)Period of lease can be thirty (30) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.
- The Government have examined and accept the proposal (FP/TN/Others/42934/2019) of the Principal Chief Conservator of Forests (Head of Forest Force) for diversion of 0.1212 ha of forest land in Thiruthuraiyur Reserved Forest of Cuddalore Forest Division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District for a period of 30 years, under section 2(1) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, subject to the following conditions and decided to forward the same to the Government of India, Ministry of Environment, Forests and Climate Change, Chennai for obtaining their concurrence:
  - i) The legal status of the diverted forest land shall remain unchanged.
  - ii) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at the 20 meter interval at the cost of user agency.
  - iii) The user agency has to pay the cost towards compensatory afforestation scheme for the selected degraded forest area in Thiruthuraiyur Reserved Forests as per the Compensatory afforestation scheme including maintenance for a period of 10 years.
  - iv) The User Agency has to pay the Net Present Value of proposed forest diversion area which will be fixed as per the guideline of Hon'ble Supreme Court of India / Government of India.
  - v) The user agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by the Forest Department in future. The user agency has to furnish undertaking to this effect.
  - vi) Amount of Compensatory afforestation scheme, Net Present Value of forest area under the project shall be transferred/ deposited to CAMPA fund only through e-portal (https://parivesh.nic.in/)
  - vii) The layout plan of the proposal shall not be changed without the prior approval of Central Government.
  - viii) No labour camp shall be established on the forest land.
  - ix) Disturbance shall be kept minimal by creating labour camps outside the forest area as far as possible and it will be the responsibility of the user agency to ensure that the machinery, labourers and staff engaged in execution of work shall not destruct nearby forest flora and fauna.
  - x) No tree felling shall be carried out by the User Agency.
  - xi) The forest land proposed for diversion shall under no circumstances be transferred or sublet to any other agency, Department or person without prior approval of the competent authority.
  - xii) The User Agency has to pay the cost towards annual lease rent for the forest area diversion period as fixed by the Forest Department at the

time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.

xiii)The total forest area utilized for the project shall not exceed 0.1212 ha area in Thiruthuraiyur Reserved Forest and the forest area diverted shall not be used for any other purpose other than those shown in the diversion proposal.

xiv) The user agency shall ensure compliance to provisions of the All Acts, Rules, Regulations and Guidelines for the time being in force, as

applicable to the Project.

xv) In the event of failure to comply with any of the above conditions, the user agency is liable for penal action as per the provisions of the Ministry of Environment Forests and Climate Change guidelines.

xvi) Period of lease is thirty (30) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest

Department.

7. I am, therefore, directed to request you to kindly obtain the concurrence of the Competent Authority and communicate the same to this Government, early.

I wish to state that, the Block Development Officer, Panchayat Union Office, Annagramam, Cuddalore District has uploaded online forest clearance proposal under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.1212 ha of forest land in Thiruthuraiyur RF of Cuddalore Forest Division for construction of BT approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District under proposal No. FP/TN/Others/42934/2019.

- 1) The User Agency has uploaded the proposal in the prescribed format of Form A Part I under Section 2 of the Forest (Conservation) Act, 1980 for diversion of fresh forest area.
- i) Name of the project and short narrative of the project in which forest land required reported as construction of approach road (BT Road), cremation shed, providing water supply to burial ground Chinnapettai village.
- ii) Area required in forest area is for 0.1212 ha., and non forest land required for the project is Zero ha., The User Agency has proposed the forest area diversion for the project for a period of 30 years.
- iii) Diversion of 0.1212 ha of forest area has been requested in Cuddalore Forest Division area in Cuddalore District. Name of the village in which forest land requested has been reported as Chinnapettai village.
- iv) The User Agency has furnished the component wise breakup details of land required for the project as follows.

a) Cremation shed  $-15m \times 15m = 225 \text{ sq.m}$  -0.0225 hab) BT road  $-152m \times 5.00m = 760 \text{ sq.m}$  -0.076 hac) Water supply hand pump -6" dia 220 ft  $-15m \times 5m = 75 \text{ sq.m}$  -0.0075 had) Street light 415 volt over transmission line -152m length -0.0152 ha
Total area -0.1212 ha

- v) The user agency has uploaded the kml file of the area proposed for diversion, scanned copy of Survey of India topo sheet indicating boundary of forest land proposed to be diverted and scanned copy of Geo referenced location map of the proposed diversion of forest area. GPS co-ordinates of the project area.
- vi) The user agency has uploaded a copy of justification report for locating the project in forest area.
- vii) The User Agency has stated that this project is not likely to generate employment. This project does not involve displacement of people due to the project and cost-benefit analysis and Environment clearance for the project are not required.
- viii) The User Agency has reported that the project or part thereof is not located in any protected area or their Eco sensitive zone and this project or a part thereof is not located in a Scheduled area.

- ix) The User Agency has stated that, the process for settlement of Rights under the Forest Rights Act 2006 on the forest land proposed to be diverted has been completed and uploaded a copy of certificate issued by the District Collector, Cuddalore in letter No. A4/720/2019, dated 07.05.2020.
- x) The User Agency has uploaded following documents in the additional information details section.
- a) The User Agency has uploaded the certificate issued by the District Collector, Cuddalore District that no alternate Government / vacant land available for the project (Letter No. A4/0720/2019, dated 20.02.2020.
- b) Certified that no violation has been carried out under the provision of Forest Conservation Act, 1980.
- c) Undertaking to bear the Net Present Value which will be fixed as per the guidelines of the Hon'ble Supreme Court of India as fixed by the Forest Department.
- d) Undertaking to bear the additional cost towards Net Present Value which will be fixed in future as per the guidelines of the Hon'ble Supreme Court of India as fixed by the Forest Department
- e) Undertaking to deposit the cost of raising compensatory afforestation / scheme as fixed by the forest department.
- f) Undertaking to bear the cost along with any escalation for exploitation of trees in the forest land to be diverted for the project.
- g) Certified that no alternative suitable non forest land is available for the project.
  - h) Certified that the demand for the forest land for the project is minimum.
- i) Undertaking to pay cost towards annual lease rent as fixed by the Forest department at the time of sanction along with any escalation for the forest land to be diverted to the above project.
- j) Further, the user agency has uploaded a copy of Thiruthuraiyur Reserve Forest Notification in which right to burial ground has been allowed for Thiruthuraiyur Hindus over a extent of one acre.

- k) The user agency has furnished the map of component wise area required for the project.
- 2) In the Part-II of Form-A, the District Forest Officer has furnished the following particulars.
- i) The District Forest Officer, Cuddalore Division has reported that the legal status of the proposed site of diversion of 0.1212 ha of forest land is 'Reserved Forests'. As per site inspection report, name of the forest land is "Thiruthuraiyur RF".
- ii) The District Forest Officer has reported that, density of the forest area is 0.1 and Eco class of forest area is five
- iii) The District Forest Officer has reported that there is no trees available in the project area. (No spontaneous or planted trees)
- iv) On vulnerability of the forest land proposed for diversion, the District Forest Officer reported that not vulnerable to erosion.
- v) The forest area proposed for diversion is not forms part of National Park, Wildlife Sanctuary, Biosphere Reserve, Tiger Reserve, Elephant corridor, Wildlife migration corridor etc., and not located within the eco-sensitive zone of the protected area notified under Wildlife (Protection) Act, 1972 not located within 1 km from boundary of NP/WLs etc.,

The District Forest Officer has reported that spotted deer, Wild pig, Reptile species are present in and around the forest land proposed for diversion. There is no rare/endangered/unique species of flora and fauna found in the area.

- vi) There is no protected archaeological/ heritage site/ defense establishment or any other important monument is located in the area.
- vii) Requirement of forest land as proposed by the User Agency is unavoidable and bare minimum for the project and no work in violation of the Act or guidelines has been carried out.
- viii) The District Forest Officer has reported that Compensatory afforestation may not be insisted as the clearance requested is for approach road to burial ground which is basic requirement for nearby people.

- ix) In the site inspection report, the District Forest Officer has stated that he inspected the area on 07.01.2021 and reported that the proposed Thiruthuraiyur RF area is having degraded forest, the existing pathway has been utilized by village people to reach the burial ground. The Rural Development Officials (user agency) explained that the activities proposed for electricity connection and bore wall are also necessary for burial ground. Right of way is also admitted as per Thiruthuraiyur RF notification. No tree felling is required for the project.
- x) In the recommendation of the project, the District Forest Officer has reported that approach road to burial ground is a basic requirement and right of way is also there, the project is recommended.
- 3) The Conservator of Forests, Villupuram Circle has also recommended the project and stated that, approach road to burial ground is a basic requirement and right of way is also there and the project is recommended.
- 4) Forest area diversion has been requested for a period of 30 years. The District Forest Officer, Cuddalore Division has recommended the proposal for 30 years. The Conservator of Forests, Villupuram Circle has recommended the project for a period of 10 years only.

Based on the recommendation of the District Forest Officer, Cuddalore Division, diversion of forest area is recommended for a period of 30 years.

- 5) State Government is empowered to accord forest area diversion up to one ha area for certain critical public utility and welfare projects undertaken by the Government as detailed below.
- (a) Schools/ Educational Institutes (b) Dispensary/ hospital (c) Electric and telecommunication lines (d) Drinking water (e) Water/ rainwater harvesting structures (f) Minor irrigation canal (g) Non-conventional sources of energy (h) Skill up-gradation / vocational training center (i) Power sub stations (j) Communication posts (k) Construction/ widening of roads including approach road to roadside establishments (l) Upgradation/ strengthening/widening of existing bridges by BRO (m) Police establishments like police stations /outposts /border outposts /towers in sensitive areas (identified by Ministry of Home Affairs) (n) Government approved community toilets partly or fully in forest lands involving not more than one-hectare subject to approval by GP in rural areas and urban bodies in urban areas, and (o) Water mills

Diversion of forest land for activities like burial ground – cremation centre is not find place in the list. Hence out of 0.1212 ha proposed for diversion, extent required for cremation shed of 0.0225 ha requires Government of India approval.

- 6) As recommended by the District Forest Officer, Cuddalore Division and Conservator of Forests, Villupuram Circle, the proposal for diversion of 0.1212 ha of forest land in Thiruthuraiyur RF of Cuddalore Forest Division for construction of approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District is recommended to the Government for consideration subject to the following conditions.
- a) The legal status of the diverted forest land remains unchanged.
- b) The demarcation of the proposed forest land shall be carried out by the User Agency by erecting 4 feet high cement concrete pillars duly numbered at an interval of 20 meters at their cost.
- c) The User Agency has to pay the amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India.

- d) The User Agency has to bear the additional amount of Net Present Value which will be fixed as per the guidelines of Hon'ble Supreme Court of India as fixed by Forest Department in future.
- e) The user agency shall compulsorily transfer the Net present Value of forest land proposed for diversion under the project to CAMPA funds only through e-portal (https://parivesh.nic.in/)
- f) The User Agency has to pay the cost towards lease rent as fixed by the Forest Department at the time of sanction along with any escalation for the forest land to be diverted of the above project in future for the entire project period.
- g) The total forest area utilized for the project shall not exceeds 0.1212 ha
- h) Period of lease can be thirty (30) years. The User Agency has to apply renewal proposal before one year of expiry of lease with the State Forest Department.
- 7) The proposal is sent herewith duly recommended by the Additional Principal Chief Conservator of Forests (Forest Conservation Act) / Nodal Officer, Forest (Conservation) Act, 1980 of the State of Tamil Nadu.
- 8) I request that the proposal may be considered and orders may be obtained from the Government of India for diversion of 0.1212 ha of forest land in Thiruthuraiyur RF of Cuddalore Forest Division for construction of approach road, cremation shed, providing water supply and street lights to burial ground of Chinnapettai village in Cuddalore District in favour of the Block Development Officer (BP), Panchayat Union, Annagramam, Cuddalore District for a Period of thirty years.
