Proposal No. FP/KA/TRANS/23066/2016.

The Government of India vide reference (1) have accorded 'in-principle' (Stage-I) approval for diversion of 1.75 hectare of forest land in Sy.No.1 of Rampura Karuvinahatti Village, Karuvinahatti Kaval Reserved Forest of Kanakapura Range, Ramanagara Division for establishing 765 KV S/C Transmission line from Darmapuri (Salem)-Madhugiri (Tumakuru) covering the States of Tamilnadu and Karnataka subject to fulfilment of certain conditions. Accordingly, the Deputy Conservator of Forests, Ramanagara Division and the Chief Conservator of Forests, Bengaluru Circle, Bengaluru were directed by this office vide reference (2) to obtain compliance report with regard to the conditions of Stage-I approval from the User Agency, verify it and then submit it to this office.

The Chief Conservator of Forests, Bengaluru Circle and Deputy Conservators of Forests, Ramanagara Division, Ramanagara have submitted the compliance report vide letters

cited under reference (3) & (4) respectively. Based on the reports received as above, the status of compliance to the conditions of Stage-I approval is submitted as under.

No.1 of Rampura Karuvinahatti Village, Karuvinahatti Kaval Reserved Forest of Kanakapura Range, Ramanagara Division for establishing 765 KV S/C Transmission line from Darmapuri (Salem)-Madhugiri (Tumakuru) covering the States of Tamilnadu and Karnataka in favour of the Chief Manager, Powergrid Limited. Singanayakanahalli, Bengaluru under the Forest (Conservation) Act, 1980 subject to submission of Original RoFR certificate by the User Agency for Condition No. 07 of Stage-I approval.
