Sub: Diversion of 1.894 ha. of forest land in Sy.No.12 & 13 of Uttarahalli Manavarthe (UM) Kaval, Bengaluru South Taluk, Bengaluru Urban District & Division for rehabilitation and upgrading of existing road to 2-lane with Paved shoulders- 4 laning from KA 438.475 (Proposed KM 45.250) Harohalli to proposed KM 461.550 (Proposed KM 458.420) Nice Road section to NH-209(Project road length 23.075 KM) in favour of the Project Director, PIU, National Highways Authority of India, Basavanapura(Ramadevarapada) Ramanagara - reg.) With reference to the above cited subject, Government of India vide Ref(1) have accorded Stage-I approval under the Forest (Conservation) Act, 1980 for the above proposal subject to certain conditions. As per condition No.(3), the User Agency has to remit Compensatory Afforestation Charges of Rs.63,72,000/- (i.e. Rs. 15,93,000/- per ha for 4 ha.) and also as per condition No.(5) SMC Charges within 200 mtrs. of road of Rs.8,00,000/- as intimated by this office Demand Notice dated: 05.11.2020 vide Ref(4).

The same was remitted and the copy of the remittance challan was submitted to this office vide letter Ref(5).

However, the Compensatory Afforestation charges have been revised vide O.M. No. A5(3).GFL.CR-28/2009-10 (E-Office File No. KFD/HOFF/A5-3(GFL)/34/2019-FC Dated: 19.04.2021.
