
Sir,

You may please note the following conditions for further compliance;


1. The activities in the project area as per Chapter-4 of the Plan will be executed by the project proponent under the guidance of DFO, Karanjia.

Further, the UA will bear the additional cost, if any, towards enhancement of wage rate and escalation of price of materials at the time of implementation of this plan. Incase of any deviation, it will be dealt as per law for violation of Forest (Conservation) Act.1980, Environment (Protection) Act.1986 & Wildlife (Protection) Act.1972.




