MEMORANDUM:-

This department has given an "in principle" approval for Diversion of **0.7795 ha.** Protected Forest land for laying of 90/125 mm dia MDPE & 4" Steel pipeline for Supply natural gas pipeline parallel & crossing (Dela&Asjol Village Connectivity, Bliss Water Park Connectivity, Mitha Village & Golf Looping Ceramic connectivity, Bhandu Village Connectivity, Baliyasan Village connectivity & 99.99 Petroleum Unjha-CNG connectivity) in Mehsana District in favour of Dy. Manager(Projects), Sabarmati Gas Ltd., Gandhinagar, vide letter dated 06.11.2018 referred at Sr. No.(1) above.

The Nodal Officer (FCA), Gujarat has reported that the User Agency has deposited an amount of Rs.3,41,421/- through NEFT/RTGS, dt.02.01.2019 towards the cost of NPV in Adhoc CAMPA, New Delhi by NEFT/RTGS(Challan) & Processing Fees and Registration fee Rs.7400/- is deposited in 8782 Forest Remittance referred at Sr. No. (2) above.

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions:-

1. This permission is granted only foruse of the forest land for the purpose specified in the proposal. The legalstatus of the forest land shall remain unchanged.

- 2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
- 3. User Agency will have to obtain permission from the Nodal Officer (FCA), for carrying out any maintenance works in future.
- 4. User Agency will have to restore the forest land after use/ maintenance work. No tree shall be cut.
- 5. User Agency will be liable to compensate any loss to Forests / Environment caused due to the use of the said land by the user agency.
- 6. User agency will seek permission from the Roads & Buildings Department/Science and Technology Department, Sachivalaya, Gandhinagar, if required so.
- 7. Gas pipeline will be laid underground in the trench of maximum depth of 2.00 meters and width of 0.5 meters, in between rows of road side plantation.
- 8. Additional conditions under chapter-5 of Forest (Conservation) Act, 1980 shall be applicable to this proposal as the Government of Gujarat's Resolution No.FCA-1013/11-10/11/SF-24/F, Dated 12.06.2015. The user agency shall be bound to comply additional condition as per the aforementioned resolution. The project authority has submitted undertakings for the same.
- 9. Any other condition, which the Nodal officer (FCA) may stipulate from time to time.
